Work on the above-noted project was found to have been performed within the requirements of the plans and specifications by the Resident Engineer. The project is substantially complete, and the Municipality has had the opportunity for input during the Final Inspection and finds the project to be acceptable

**Location & Description of the Project:**

MIDDLEBURY WCRS (23) - LOCATED IN THE COUNTY OF ADDISON, TOWN OF MIDDLEBURY, ON MAIN STREET (TH 2); BRIDGE NO. 102 OVER VERMONT RAILWAY, APPROXIMATELY 400 FT SOUTHWEST OF THE INTERSECTION OF MAIN STREET AND US ROUTE 7, AND ON MERCHANTS ROW (TH 8); BRIDGE NO. 2 OVER VERMONT RAILWAY, APPROXIMATELY 230 FT WEST OF THE INTERSECTION OF MERCHANTS ROW AND SOUTH PLEASANT STREET (TH 47).

WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES THE REMOVAL AND REPLACEMENT OF BRIDGE NO. 102 AND BRIDGE NO. 2 WITH A TUNNEL ALONG A MODIFIED RAILROAD ALIGNMENT, LOWERING OF TRACKS, CONSTRUCTION OF APPROACH RETAINING WALLS (U-WALLS), AND ROADWAY AND UTILITY WORK. THE PRECEDING WORK OF EWP3 (2) INCLUDES MICROTUNNELING FOR SELECT DRAINAGE IMPROVEMENTS, CONSTRUCTING AN ACCESS ROAD TO THE DRAINAGE OUTFALL, AND CONSTRUCTING A TEMPORARY ACCESS ROAD.
