MINT HILL EVENTS TERMS AND CONDITIONS

- Arts and Crafts exhibitors must make all items sold. The artist creating the craft must be present and selling their own goods.
 - Mint Hill Events has sole discretion on acceptability of work and reserves the right to remove any items from exhibitors' booths if deemed inappropriate.
 - Vendor spaces are 10' x 10'. **NO GENERATORS ARE ALLOWED.** Because of the feedback we received we are changing the layout for 2017. The stage is moving to the lower field and all booths will be moved to the field closer to the rides. **NO GENERATORS WILL BE ALLOWED.** Electricity will be available to a limited number of spaces. Festival lighting will be available, and vendors will have the opportunity to stay open until 11 pm.
 - Exhibitors are not to relocate or move from their assigned spaces. Exhibitors must not infringe on other spaces or in public space area, or 'trade' spaces.
 - Exhibitors are to provide their own tent, table, and chairs. Be advised the event is outside. Please take precautions to secure your tent. No ground stakes are allowed.
 - If you have not arrived by 2 PM on Thursday afternoon, you will be considered a no-show. **NO REFUNDS** will be offered and you may be banned from future events.
 - **ABSOLUTELY NO VEHICLES** in the area after 3 PM on Thursday. **Vendors should expect to leave their booths intact until breakdown after the fireworks on Saturday night.** For safety reasons, vehicles will not be allowed into the area until pedestrian traffic has cleared. **NO EXCEPTIONS.**
 - Night security will be on site, however, we request you take your valuables with you. Mint Hill Events, Inc. and the Town of Mint Hill are not responsible for lost or stolen items.
 - Mint Hill Madness is a RAIN OR SHINE event, and all exhibitors are expected to participate at all times. (Vendors who are not Food Vendors may leave at 8 PM, but are welcome to stay open until the event closes.)
 - **NO PETS ALLOWED! NO EXCEPTIONS!**
 - Exhibitors are responsible for reporting and paying required sales tax to NC and Mecklenburg County. Contact: Registration Information, 704-519-3000.
 - In the event that a vendor must cancel their space, we must receive a written cancellation request by October 1st. Refunds of the space fees will only be offered up to October 1st. No refunds are offered after that day for ANY reason including weather, acts of God, extenuating circumstances, etc.
