

JULY 20, 2022

The Monett City Council met in regular session, Wednesday, July 20, 2022, at 9:31 a.m. at the Monett Park Casino, Highway 37 and 60, Monett, Missouri. Attendance was as follows: Mike Brownsberger, Mayor; Al Dohmen, Commissioner; Christopher Weiner, City Administrator; Angie Irwin, Deputy City Clerk; Georges Daoud, Police Chief; Melanie Roberts, media; Ken Olson, Enterprise Fleet Management; and 4 others from Anderson Engineering.

Mayor Brownsberger called the meeting to order.

The Minutes from the previous sessions dated June 20, 2022, June 21, 2022, and June 29, 2022, were approved with a motion from Commissioner Dohmen and a second from Mayor Brownsberger. The following vote was recorded: Brownsberger – yes, Dohmen – yes.

Monthly expenditures in the amount of \$4,068,578.55 were presented for approval. Commissioner Dohmen made a motion to approve the expenses, and a second was heard from Mayor Brownsberger. The following vote was recorded: Brownsberger – yes, Dohmen – yes.

BILL 8915: AN ORDINANCE OF THE CITY OF MONETT, MISSOURI, IMPOSING A USE TAX FOR GENERAL REVENUE PURPOSES AT THE RATE EQUAL TO THE TOTAL LOCAL SALES TAXES IN EFFECT FOR THE PRIVILEGE OF STORING, USING, OR CONSUMING WITHIN THE CITY ANY ARTICLE OF TANGIBLE PERSONAL PROPERTY PURSUANT TO THE AUTHORITY GRANTED BY AND SUBJECT TO THE PROVISIONS OF SECTIONS 144.600 THROUGH 144.761 RSMo; PROVIDING FOR THE USE TAX TO BE REPEALED, REDUCED, OR RAISED IN THE SAME AMOUNT AS ANY CITY SALES TAX IS REPEALED, REDUCED, OR RAISED; AND PROVIDING FOR SUBMISSION OF THE PROPOSAL TO THE QUALIFIED VOTERS OF THE CITY FOR THEIR APPROVAL AT THE GENERAL ELECTION CALLED AND TO BE HELD IN THE CITY ON THE EIGHTH (8TH) OF NOVEMBER 2022.

Bill 8915 was presented for second reading and approval. Motion to approve was made by Mayor Brownsberger and seconded by Commissioner Dohmen. The following vote was recorded: Brownsberger – yes, Dohmen – yes.

BILL 8920: AN ORDINANCE OF THE CITY OF MONETT, MISSOURI, LOWERING THE MINIMUM REQUIRED AGE TO BE EMPLOYED AS A FULL TIME FIREFIGHTER WITH THE CITY OF MONETT

Bill 8920 was presented for first reading. Second reading was set for August 19, 2022.

BILL 8921: AN ORDINANCE APPROVING A PRELIMINARY PLAT FOR THE MONETT ESTATES SUBDIVISION

BILL 8922: A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO FILE A PETITION WITH THE BARRY COUNTY COMMISSION TO INITIATE A COUNTY ROAD RELOCATION AS PART OF THE MONETT REGIONAL AIRPORT EXPANSION PROJECT

BILL 8923: A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT WITH ENTERPRISE FLEET MANAGEMENT
