

Minutes of the Meeting of the Monett City Council

June 20th, 2022

The Monett City Council met in regular session, Monday, June 20th, 2022 at 9:30 a.m. at the Monett Park Casino, Highway 37 and 60, in Monett, Missouri. In attendance was as follows: Mike Brownsberger, Mayor; Al Dohmen, Commissioner; Ken Gaspar, Commissioner; Chris Weiner, City Administrator; Georges Daoud, Chief of Police; and Melonie Roberts, Monett Times Reporter.

Mayor Brownsberger called the meeting to order at 9:30 a.m.

The minutes from the previous sessions dated May 20th, 2022 and June 9th, 2022, ere approved with a motion from Commissioner Gaspar, and a second from Commissioner Dohmen. The following vote was recorded: Brownsberger – yes, Dohmen – yes, and Gaspar – yes.

Monthly expenditures in the amount of \$1,149,337.01 were presented for approval. Commissioner Gaspar made a motion to approve the expenses, and a second was heard from Commissioner Dohmen. The following vote was recorded: Brownsberger – yes, Dohmen – yes, and Gaspar – yes.

First and Second Reading of Bill and Ordinance Number 8913: Approval of Supplemental Agreement #4 for the Monett Regional Airport Runway Expansion Project

Bill 8913 was presented for a first and second reading. Commissioner Gaspar motioned to approve Bill 8913 while Commissioner Dohmen seconded the motion. The following vote was recorded: Brownsberger – yes, Dohmen – yes, and Gaspar – yes.

First and Second Reading of Bill and Ordinance Number 8914: Dedication of Farm Road 2025 to Barry County, Missouri

This item was tabled for the July meeting.

First Reading of Bill and Ordinance Number 8915: Adopting a Use Tax for the City of Monett

Bill 8915 was presented for first reading. Second reading was set for July 20th, 2022.

Consideration of Bill and Resolution Number 8916: Authorizing the Filing of an Application for the Missouri Department of Natural Resources ARPA Grant Program

Bill 8916 was approved by a motion from Commissioner Dohmen and a second from Commissioner Gaspar. The following vote was recorded: Brownsberger – yes, Dohmen – yes, and Gaspar – yes.

Consideration of Bill and Resolution Number 8917: Authorizing the Purchasing Card Agreement with Arvest Bank

Bill 8917 was approved with a motion from Commissioner Gaspar and a second from Commissioner Dohmen. The following vote was recorded: Brownsberger – yes, Dohmen – yes, and Gaspar – yes.

Consideration of Bill and Resolution Number 8918: Authorizing the Destruction of Certain Old Law Enforcement Records

Bill 8918 was approved with a motion from Mayor Brownsberger and a second from Commissioner Gaspar.

Consideration of Bill and Resolution Number 8919: Approving a Lease Renewal Agreement with Paul Adams Livestock Grazing

Bill 8919 was approved with a motion from Mayor Brownsberger and a second from Commissioner Dohmen.

Having no further business to discuss, the meeting was adjourned at 9:52 a.m. with a motion from Commissioner Gaspar, and a second from Commissioner Dohmen. The following vote was recorded: Brownsberger – yes, Dohmen – yes, Gaspar – yes.
