

## **MARCH 21, 2022**

The Monett City Council met in regular session, Monday, March 21, 2022, at 9:30 a.m. at the Monett Park Casino, Highway 37 and 60, Monett, Missouri. Attendance was as follows: Mike Brownsberger, Mayor; Al Dohmen, Commissioner; Ken Gaspar, Commissioner; Christopher Weiner, City Administrator; Angie Irwin, Deputy City Clerk; Georges Daoud, Police Chief, and one other.

Mayor Brownsberger called the meeting to order.
