FEE SCHEDULE

Pavilion Rental \$50.00 per Hour

The Pavilion closing time is 11:00 p.m. All people and equipment must be out of the park and Pavilion at this time.

USE POLICY

- (1) There are no exceptions or discounts to the adopted fee schedule for any individuals or groups reserving the Monett Pavilion.
- (2) No date will be reserved for any individual or group until payment in full is received by the City Collector within 2 weeks prior to the event and the renter has submitted a fully executed Rental Agreement.
- (3) Reservations shall be made by calling 417-235-4654 or email: dmyers@monettmo.gov
- (4) No alcohol is permitted in the park or Pavilion.
- (5) The individual or group reserving the facility shall be responsible for any damage done to the Pavilion or contents during the event. The City may require a damage deposit in advance of the event.
- (6) The City of Monett shall not be responsible for items lost, stolen or broken during the Event.
- (7) All decorations or displays shall be removed or disposed of by the renter. The City of Monett reserves the right to dispose of materials or supplies left behind by the renter.
- (8) The City shall maintain full authority over the Pavilion and may deny reservations or use of the facility for inappropriate activities or due to misconduct or failure to abide by the facilities policies.
- (9) All trash shall be put in the trash receptacles and all picnic tables placed back under the pavilion
- (10) Pavilion reservations include the Pavilion only. Splash pad and park are for public use.
- (11) Barbeque grills and smokers are not allowed in the Pavilion or on the grass around Pavilion. Barbeque grills and smokers are allowed on the Southside of Front Street in the parking lot.
- (12) Only Small 10'x10' shade canopy type tents are allowed to be set up in the grass area and secured with weights only! NO STAKES ARE TO BE DRIVEN due to the sprinkler system.**
