

Its goal is to be a dynamic and innovative organization that works with volunteers, other organizations and the City of Monroe for the betterment of downtown.



Vision




Vision: In 2027, downtown Monroe will be a vibrant and walkable destination where retailers, restaurants, and residential spaces combine into a lively shopping and entertainment district. All historic buildings have made improvements from façade renovations to new signage and outdoor seating. The downtown is united by an attractive, functional streetscape that is welcoming and accessible to all.



Strategic Plan Goals

The Monroe DDA adopted a 5-Year Strategic Plan in 2012. The Plan includes tactics to compel an economic and place-based focus to the DDA's work and to help the DDA prepare for implementation of the Downtown Master Plan. The DDA will accomplish its work in support of seven overall goals.



They are:

- 1. Inform and educate building owners and public of the actions and accomplishments of the DDA and businesses
- 2. Support downtown business and property owners through financial support, advocacy and awareness.
- 3. Preserve and enhance downtown by facilitating redevelopment.
- 4. Market the downtown to encourage people to frequent local businesses and events.




Strategic Plan Goals

- 5. Serve as an intermediary of the organizations that connect to downtown and link to other community
- 6. Establish an environment that promotes residential growth downtown.
- 7. Encourage compliance with city codes and ordinances to protect and limit risk to investment in properties and businesses.



TIF Funding Fiscal Year 2021-22



The projects and programs of the Monroe DDA primarily are funded through a mechanism called tax increment financing. The DDA captures taxes from growth in property values from its base year, or year of creation of its TIF Plan; in this case, 1990.

Each year, the DDA engages in a planning process to allocate funds to projects and programs which accomplish its goals. A corresponding budget is created and submitted to the City Council for approval.



Accomplishments for 2021-2022

Highlights include:

- Finalized design for Riverwalk Connectors and accepted bids for lighting portion
- Redesigned the Downtown Monroe website
- Replaced site furnishings benches, waste receptacles, planters and bike racks – in accordance with streetscape design guidelines
- Purchased over-the-road lighted holiday swags
- Conducted a site-specific residential market analysis





- Developed a 2022-2027 Strategic Plan
