An ordinance levying taxes for all town purposes for New Lenox Township, Will County, Illinois, for the tax year 2022, collectible in 2023

BE IT ORDAINED by the Board of Trustees of New Lenox Township, Will County, Illinois, as follows:

SECTION 1: That the sum of One Million Four Hundred Forty Three Thousand Seven Hundred Fourteen Dollars (\$1,443,714.00) and hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

- GENERAL ASSISTANCE**

SECTION 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.
