

Newport Resident,

The City is considering a project to install sanitary sewer liners on your service line where it connects to the sewer main. The intent of the project is to seal this connection point and prevent groundwater from entering the sanitary sewer collection system. The City Council has set a date for the first public hearing to discuss the proposed improvements. At the public hearing, a presentation will be made by the City's Engineer who will discuss the project feasibility study including information on the proposed improvements, project costs, necessity and cost effectiveness, schedule for construction, and potential assessments to your property.

City of Newport Notice of Hearings on Improvement

Notice is hereby given that the City Council of Newport will meet in the Council Chambers of City Hall, 2060 1st Avenue, Newport, MN 55055 at 5:00 P.M. on August 31, 2022, to consider the making of the Lateral Lining Improvement Project. This is an improvement to 2nd and 3rd Avenues from Unity Boulevard to 21st Street, 21st Street from 1st Avenue to 7th Avenue, 1st Avenue from 21st Street to 17th Street, Cedar Lane from 17th Street to 2nd Avenue, 16th and 15th Streets from 2nd Avenue to Cedar Lane, 2nd Avenue from Cedar Lane to South Terminus (4th Street), an easement from Cedar Lane to 10th Street (Lying west of 2nd Avenue), 15th Street from 2nd Avenue to the Mississippi River, 11th Street from 3rd Avenue to 2nd Avenue, 3rd Avenue from 11th Street to Park Place, 10th Street from 2nd Avenue to the Mississippi River, 9th Street from 4th Avenue to 2nd Avenue, Park Place from 3rd Avenue to 2nd Avenue, 5th Street from 2nd Avenue to the Mississippi River, 9th Avenue from 12th Street to Tibbetts Place, and Tibbetts Place from Hastings Avenue to 9th Avenue by improving sanitary sewer service laterals pursuant to Minn. Stat. §§ 429.011 to 429.111. The area proposed to be assessed for such improvement is all properties within the aforementioned project area and other properties receiving benefit from new utility services. The estimated cost of the improvement is \$2,100,000. A reasonable estimate of the impact of the assessment will be made available at the hearing. Such persons as desire to be heard with reference to the proposed improvement will be heard at this meeting.

This public hearing, often referred to as the "improvement hearing", is a critical part of the MN State Statutes Chapter 429 requirements for imposing special assessments on properties benefiting from local improvements. It is important to note that there are many steps in the process remaining before the actual assessment can be levied.
