**RESOLUTION SETTING THE SALARY OF THE NIAGARA COUNTY SHERIFF**

WHEREAS, the State of New York requires that the salary of the Sheriff be set prior to the start of his term, and

WHEREAS, Sheriff Elect Filicetti has been the Acting Sheriff of Niagara County since January 1, 2020, and

WHEREAS, the Acting Sheriff has very effectively led the Sheriff's Office through large changes in 2020, and

WHEREAS, New York State instituted new Bail Reform and Discovery Laws which necessitated policy and procedural changes in the Jail, Dispatch Center, Forensic Laboratory and Road Patrol, and

WHEREAS, the Sheriff led through changes in procedures in Road Patrol, Dispatch and the Jail due to the Coronavirus, and

WHEREAS, the Sheriff managed effective responses to protests throughout Niagara County to promote the safety of Niagara County, and

WHEREAS, the Sheriff instituted the New York State mandated Police Reform with excellent communication and community involvement, and

WHEREAS, the Sheriff has fostered increased partnerships throughout Niagara County as evidenced by the Sheriff's weekly conference calls with the County's Police Chiefs, the Building Bridges Program with Niagara Falls PD and the expansion of the Explorer's Program to the western part of the County, and

WHEREAS, the Sheriff manages 18 divisions and 332 employees, now, therefore, be it

RESOLVED that the salary of the Sheriff shall be set as follows: \$123,290 per year commencing January 1, 2021, \$125,756 per year commencing January 1, 2022, \$128,271 per year commencing January 1, 2023 and \$130,836 per year commencing January 1, 2024.
