

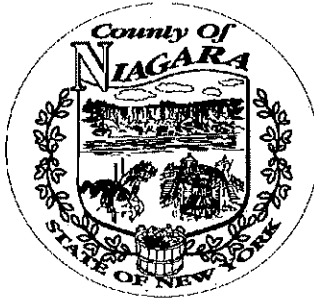



WHEREAS a comprehensive Employee Assistance Program (EAP) service provides training, coaching, counseling, and wellness programs to assist employees and their family members in achieving their best performance and reach their peak potential, and

WHEREAS an Employee Assistance Program will also benefit the County of Niagara as a result of this important service that is available for its employees, and

WHEREAS, the contract with INOVA EAP has expired, and

WHEREAS, the County of Niagara has selected a competitive bid for professional services as a result of the RFP process, and would like to grant the contract to Employee Services, LLC. - ESI Employee Assistance Group for Employee Assistance Program services for the time period of May 1, 2024 through April 30, 2027, and

WHEREAS, the fee for EAP services per each year of the contract shall be \$19.00 per employee per year, approximately \$28,063 annually, and


WHEREAS, prior to the execution of the contract, the County Attorney will review the contract for approval as to legal form, language and compliance, now, therefore, be it



APPROVAL OF VOTING MACHINE AGREEMENT BETWEEN THE COUNTY OF NIAGARA AND THE NIAGARA FALLS, LOCKPORT, NORTH TONAWANDA, LEW-PORT, NEWFANE, NIAGARA WHEATFIELD, ROY-HART, STARPOINT, SCHOOL DISTRICTS, THE VILLAGE OF LEWISTON AND THE VILLAGE OF YOUNGSTOWN (§3-224, NEW YORK STATE ELECTION LAW)

WHEREAS, the Niagara Falls, Lockport, North Tonawanda, Lew-port, Newfane, Niagara Wheatfield, Roy-Hart, Starpoint School Districts, and the Village of Youngstown will be conducting elections on May 21, 2024, May 20, 2025, May 19, 2026, May 18, 2027, May 16, 2028, and the Village of Lewiston on June 18, 2024, June 16, 2026, June 20, 2028 and requires the use of the Niagara County Board of Elections voting equipment in connection with this election, and

WHEREAS, a formal agreement will be prepared with the Niagara County Attorney's Office for use between the County of Niagara and the Niagara Falls, Lockport, North Tonawanda, Lew-port, Newfane, Niagara Wheatfield, Roy-Hart, Starpoint School District the Village of Lewiston and the Village of Youngstown, which will be fully approved by the District, and a copy of will be filed with the Clerk of the Legislature, and

WHEREAS, time is of the essence in connection with the approvals by the Niagara County Legislature, and

WHEREAS, under the terms of the agreement the County will provide, and be reimbursed for voting machine preparation, programming, and packaging of the voting machine and all necessary Niagara County personnel: the District, among other things, shall furnish at its expense, election custodians and inspectors, and also insurance in form, content and amounts as approved by the Niagara County Attorney, and

WHEREAS, the final written agreement between the parties is subject to the review and approval by the parties' respective legal counsel, now, therefore, be it



PARTICIPATE IN AND RECEIVE FUNDS FROM NYS FRONTLINE HEALTH CARE WORKER BONUS PROGRAM FIFTH VESTING PERIOD - DEPARTMENT OF HEALTH

WHEREAS, Governor Hochul launched the Health Care Worker Bonus Program pursuant to Part ZZ of Chapter 56 of the Laws of 2022, and

WHEREAS, the Health Care Worker Bonus Program allows qualified employers to issue bonus payments to frontline health care workers to “recruit, retain, and reward health care and mental hygiene workers” meeting specified eligibility requirements, and

WHEREAS, the bonus amounts will be commensurate with the number of hours worked by eligible workers covered by the Health Care Worker Bonus Program during the five designated vesting periods for up to a total of \$3,000 per covered worker, and

WHEREAS, vesting periods designated as Vesting Period Vesting Period 5: 10/1/23 – 3/31/24, and

WHEREAS, that qualified employees who work at least 20 hours but no more than 30 hours per week are eligible for a bonus of \$500, qualified employees who work at least 30 but no more than 35 hours per week are eligible for a bonus of \$1,000, qualified employees who work at least 35 hours per week are eligible for a bonus of \$1,500, and

WHEREAS, that qualified employees are eligible for up to two vesting periods and the maximum any qualified employee may receive is \$3,000, and

WHEREAS, the funds to pay for this initiative will be paid by the NYS Frontline Health Care Worker Bonus Program, and

WHEREAS, eligible frontline direct care health and mental hygiene care workers are designated by title within the regulation, and

WHEREAS, Niagara County is designated as a qualified employer and must provide eligible employees with an Employee Attestation Form which must be completed and returned to Niagara County administration prior to submitting claims for bonus payments, and

WHEREAS, Niagara County as a qualified employer must submit timely claims to NYS and must pay timely approved and funded bonus amounts to qualified employees based on the number of hours worked during the applicable vesting periods, now, therefore, be it

A LOCAL LAW TO CREATE EXCEPTIONS TO THE RESIDENCY REQUIREMENT FOR ASSISTANT DISTRICT ATTORNEYS

WHEREAS, the Niagara County District Attorney's Office has had insufficient staffing of Assistant District Attorneys for more than three (3) years, and

WHEREAS, the Niagara County District Attorney's Office currently has six (6) open positions for Assistant District Attorney, and

WHEREAS, several candidates for the position of Assistant District Attorney have withdrawn their names from consideration or not applied because of the residency requirement, and

WHEREAS, there have been continuous postings for openings for the position of Assistant District Attorney in various places for the past two (2) years, and

WHEREAS, this local Law is being proposed by the Niagara County Legislature due to the inability to hire Niagara County residents to the position of Niagara County Assistant District Attorney.

Be it enacted by the Legislature of the County of Niagara, New York, as follows:

Section 1. Preface: It is the strong desire of the Niagara County community to install Niagara County residents in the position of Assistant District Attorney of Niagara County. It is a strong belief of Niagara County that Niagara County residents are knowledgeable about and concerned with the affairs of Niagara County.

Section 2. Purpose: It is the purpose of this Local Law to confirm the commitment of Niagara County to hire residents who have the necessary qualifications and skills to meet the requirements of the position of Assistant District Attorney of Niagara County. This law will permit Niagara County to make an exception to the residency requirement of the Public Officers Law for the hiring of Assistant District Attorneys.

Section 3. Authority: An assistant district attorney is a local public officer. Those holding that office are, therefore, subject to the provisions of section 3 of the Public Officers Law, which requires residency in the county within which their functions are exercised. Section 10(1)(ii)(a)(1) of the Municipal Home Rule Law, empowers a county to adopt local laws that are not inconsistent with the constitution or any general law, including the residency of its officers and employees. The County of Niagara can supersede Section 3 of the Public Officer's Law with respect to the office of Assistant District Attorney, in that section 3 has become a special rather than a general law due to the exemption of the counties of Essex, Fulton, Madison, Montgomery, Putnam, Schuyler, Wyoming, and Yates, in that it does not by its terms, apply alike to the office of district attorney in every county.

Section 4. Authorization: The District Attorney is hereby authorized to make exceptions to the residency requirement to Assistant District Attorneys from outside Niagara County.

Section 5. Effect: This Local Law shall take effect upon filing in the Office of the Secretary of State pursuant to the provisions of Article 3 section 27 of the Municipal Home Rule Law.
