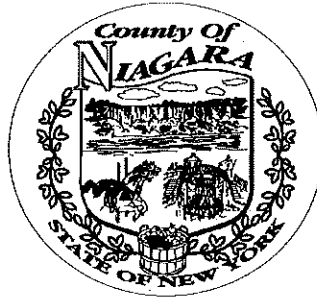



## APPROVAL OF VOTING MACHINE AGREEMENT BETWEEN THE COUNTY OF NIAGARA AND THE NIAGARA FALLS, LOCKPORT, NORTH TONAWANDA, LEW-PORT, NEWFANE, NIAGARA WHEATFIELD, ROY-HART, STARPOINT, SCHOOL DISTRICTS AND THE VILLAGE OF YOUNGSTOWN (§3-224, NEW YORK STATE ELECTION LAW)

WHEREAS, the Niagara Falls, Lockport, North Tonawanda, Lew-port, Newfane, Niagara Wheatfield, Roy-Hart, Starpoint School Districts and the Village of Youngstown will be conducting an election on May 16, 2023 and requires the use of the Niagara County Board of Elections voting equipment in connection with this election and

WHEREAS, the Niagara County Attorney's Office has prepared a formal agreement for use between the County of Niagara and the Niagara Falls, Lockport, North Tonawanda, Lew-port, Newfane, Niagara Wheatfield, Roy-Hart, Starpoint School District and the Village of Youngstown, which has been fully approved by the District, a copy of which has been filed with the Clerk of the Legislature, and

WHEREAS, time is of the essence in connection with the approvals by the Niagara County Legislature and

WHEREAS, under the terms of the agreement the County will provide, and be reimbursed for voting machine preparation, programming, and packaging of the voting machine and all necessary Niagara County personnel: the District, among other things, shall furnish at its expense, election custodians and inspectors and also insurance in form, content and amounts as approved by the Niagara County Attorney, and

WHEREAS, the final written agreement between the parties is subject to the review and approval by the parties' respective legal counsel, now, therefore, be it



WHEREAS, the Niagara County Department of Mental Health & Substance Abuse Services has received permission to fill several vacant positions within the Department of Mental Health and Substance Abuse Services, which are critical for maintaining quality service to Niagara County residents, and

WHEREAS, due to long standing challenges with recruitment and professional workforce shortages for Master's Level Clinical positions, Niagara County has opened the Licensed Clinician Civil Service Exams to residents of counties contiguous to Niagara County, and

WHEREAS, all Niagara County candidates who are currently on the eligible Civil Service lists for these positions have been hired by the Department, and

WHEREAS, the Department has made a diligent and sincere effort to recruit candidates for these positions from within Niagara County, including through the County website, social media pages, job/career fairs, and job recruitment sites, and

WHEREAS, the department continues to prioritize the hiring of Niagara County residents for these positions when available, and

WHEREAS, these positions will be filled provisionally until the next round of Civil Service Exams is given, and

WHEREAS, any provisional employee must pass and be reachable on the Civil Service examination, now, therefore, be it

### A & D BOIVIN DESIGN INC SOLE/ SINGLE SOURCE DESIGNATION FOR PURCHASE OF SNOW TRACKS FOR TRUCKS

WHEREAS, the Niagara County Legislature passed Resolution CSS-012-23 on February 21, 2023 approving the Niagara County Sheriff's Office and the Niagara County Emergency Management Office to purchase equipment for better snow emergency preparedness, and

WHEREAS, one identified need was to improve the ability to travel during an extreme snow emergency into areas that traditional vehicles cannot travel, and

WHEREAS, the Trackngo system is a unique track system which is designed for emergency applications and will convert an all-wheel drive truck into a track system within 15 minutes thus allowing it to rapidly respond during a snow emergency, and

WHEREAS, A & D Boivin Design Inc. has a patent on the Trackngo system and is the sole distributor, now, therefore, be it

**NIAGARA COUNTY SHERIFF'S OFFICE  
EXPENDITURE OF CELLULAR E911 FUNDS  
TO CONNECT THE JAIL TOWER GENERATOR INTO THE ALARM SYSTEM**

WHEREAS, the Niagara County Legislature passed a Local Law on 11/5/2017 which established an E911 surcharge for cellular phones to establish a dedicated revenue to be used for future payments for system costs, eligible wireless 911 service costs, or other costs associated with the administration, design, enhanced wireless 911 service costs serving Niagara County, and

WHEREAS, such expenditures require the authorization of the Niagara County Legislature, and

WHEREAS, the Sheriff's Office has identified a need to connect the Jail Communications Tower Generator into the alarm system to alert the Sheriff's Office Communications Center in the event of a power issue or generator issue with the tower, and

WHEREAS, the Sheriff's Office already monitors the other Communications Towers so it is critical to have the same information on the Jail Tower in order to ensure rapid communication of any issues, and

WHEREAS, the funds are already in the 2023 Budget, now, therefore, be it

RESOLVED, that the Niagara County Sheriff's Office be authorized to spend up to \$10,000 in cellular E911 funds for the necessary project to connect the jail tower generator into the alarm system, following Purchasing Guidelines.

## NIAGARA COUNTY SHERIFF'S OFFICE MCP ACQUISITION CORPORATION CONTRACT CHANGE ORDER NO. 1

ACCEPT OFFICE OF INDIGENT LEGAL SERVICES (OILS)  
DISTRIBUTION #13 (C130029) GRANT**

WHEREAS, the Niagara County Public Defender's Office has received an award from the New York State Office of Indigent Legal Services (OILS) in the amount of \$329,289 for the period of January 1, 2023, through December 31, 2025, and

WHEREAS, these funds are to be used to improve the quality of legally mandated representation in Niagara County, and

### NIAGARA COUNTY SUPPORT FOR NYSAC AND NYSCOPA PROPOSALS TO IMPROVE PROBATION AND ALTERNATIVES TO INCARCERATION PROGRAMS IN NEW YORK STATE

WHEREAS, County Probation Departments are an integral part of the Criminal Justice System and operate within the legal framework of the Criminal Procedure Law, the Penal Law and the Family Court Act, and

WHEREAS, it is the mission of probation to protect the community through intervention in the lives of those under supervision by facilitating compliance with court orders and serving as a catalyst for positive change, and

WHEREAS, state funding for probation was drastically reduced between 1990 and 2022 from a 46.5 percent State share in 1990 to less than 10 percent in 2022, putting a huge strain on counties and cost to county property taxpayers, and

WHEREAS, at the same time there have been increases in the number of mandated programs and services county probation departments are required to provide, and

WHEREAS, the New York State Council of Probation Administrators (NYSCOPA), representing New York State Probation Directors, Administrators, and Commissioners has diligently worked with the New York State Association of Counties (NYSAC) and State leaders to bring more awareness to the important work that Probation does to protect the public, now, therefore, be it

RESOLVED, that the Niagara County Legislature supports proposals put forward by NYSAC to immediately enact statutory and regulatory changes that improve Probation and Alternatives to Incarceration in the following ways:

- 1) In response to raise the age legislation:
  - a) Mandate that the state's evidence-based criteria should account for existing local best practice programs.
  - b) Allow probation the ability to make an application to Family Court for a temporary order of protection as a part of the adjustment process.
  - c) Authorize law enforcement agencies to issue appearance tickets if deemed appropriate by the arresting officer, instead of physical arrest, when adolescent offenders and juvenile offenders are charged with most D felonies.
  - d) Allow law enforcement agencies to deliver adolescent offenders and juvenile offenders to be held in detention facilities after hours without a securing order until the youth part is in session.

- 2) Establish a dedicated funding stream through Division of Criminal Justice Services (DCJS) Office of Probation and Correctional Alternatives (OPCA) for 100 percent of all local probation costs including but not limited to probation personnel and evidence-based programming associated with raise the age legislation.
- 3) Eliminate the requirement of a sentence of a conditional discharge or probation for Leandra's Law cases when a defendant has been sentenced to a definite jail term or a term of imprisonment.
- 4) That local probation departments receive reimbursement for 100 percent of all pre-trial services cost including but not limited to probation personnel associated with bail reform.
- 5) That the executive chamber and the Office of Children and Families Services (OCFS) work towards transitioning some of the closed OCFS or department of correctional and community supervision facilities to accommodate the lack of specialized secure detention beds as well as allowing county consortiums to open specialized secure detention facilities if desired.



WHEREAS, while the intent of the Local Law was to place the liability for end-of-life of solar panels squarely on the Manufacturers, Project Developers/Project Owners have expressed an interest in assuming the responsibility and liability on behalf of manufacturers for the site Developers/Owners specific projects, and

WHEREAS, a Project Developer/Project Owner or any other entity may wish to assume liability under Section 2(8)(g) and have a Stewardship Plan approved without having been able to obtain acknowledgement from the selected Panel Manufacturer whose panels are being used on a project, and

WHEREAS, rules and regulations are needed to fully set forth the assumption of liability that is assumed by someone beyond a Manufacturer, or a Stewardship Organization that is explicitly representing the Manufacturer, now, therefore, be it

RESOLVED, that Rules and Regulations for acknowledgement and assumption of responsibility and liability beyond that acknowledged by a Manufacturer are as follows:

- (1) Should an entity applying pursuant to Section 2(8)(g) submit a Stewardship Plan not have acknowledgement by the manufacturer of their selected panels may assume the responsibility and liabilities of Local Law No. 4 of 2021 by submitting the following:
  - a. Proof of attempt to contact the Panel Manufacturer of said project(s) in their plan by either supplying a copy of an electronic or hard copy letter correspondence that was sent to the Manufacturer requesting their acknowledgement, and
  - b. Section 2(8)(g) Designation Form, which includes signatures by the Entity Applying under Section 2(8)(g) and the Land Owner(s) should they be different individuals/groups, as well as the included language of assumption of all requirements and liabilities under Local Law No. 4 for 2021.

### A RESOLUTION PROCLAIMING APRIL AS DONATE LIFE MONTH IN NIAGARA COUNTY

WHEREAS, in New York State there are approximately 8,100 people waiting for an organ transplant which represents the third highest need in the nation; and there are an estimated 400 New Yorkers that die every year while waiting for an organ transplant, and

WHEREAS, a single individual's donation of the heart, lungs, liver, kidneys, pancreas and small intestine can save up to eight lives; donation of tissue can save and heal the lives of up to 75 others, and

WHEREAS, organ, eye and tissue donation are life-giving and healing acts recognized worldwide as expressions of compassion to those in need, and

WHEREAS, New York State's County governments play a key role in raising awareness of the need for organ, eye and tissue donation through the interactions County officials have with the public with regard to this subject through local DMV offices, local boards of elections, departments of health, naturalization ceremonies and veterans' programs, and

WHEREAS, such interactions by Niagara County officials with the public provide opportunities for the provision of information on how individuals can help their fellow New Yorkers by signing up as organ and tissue donors, and

WHEREAS, counties across New York State are proclaiming the month of April 2023 as "Donate Life Month," and engaging in various awareness activities designed to promote an increase in the number of registered organ, eye and tissue donations, and

WHEREAS, the Niagara County Clerk's Office, through its Department of Motor Vehicles, wish to promote the month of April 2023 as "Donate Life Month" in Niagara County, now, therefore, be it
