**EXTENSION OF MEDICAL CLAIMS ADMINISTRATION CONTRACT BETWEEN AND AMONG  
NIAGARA COUNTY, THE NIAGARA COUNTY HEALTH PLAN AND NOVA  
HEALTHCARE ADMINISTRATORS, INC.**

WHEREAS, Niagara County, the Niagara County Health Plan ("NCHP") and the Niagara County Legislature previously authorized the signing and delivery of a current contract between NCHP and Nova Healthcare Administrators, Inc. ("NOVA") for the provision of medical claims administration services from January 1, 2013 to December 31, 2017 for the NCHP, and

WHEREAS, NOVA has rendered professional and competent services to the County and to NCHP pursuant to said contract, and

WHEREAS, NCHP requires, and Nova has offered, to render the same professional services set forth in said agreement at the same per employee per month fee and menu of services pricing attached (in Exhibit C) as it charged NCHP for the period covered by the previous agreement, and

WHEREAS, the NCHP and the Joint Labor/Management Healthcare Committee have reached consensus to conduct a Request for Proposal ("RFP") for Third Party Plan Administration ("TPA") services through Niagara County Purchasing in 2018 for a January 1, 2019 contract start, and

WHEREAS, such measures serve to strategically align the TPA medical claims services contract with the current Pharmacy Benefit Administration Services contract term; now, therefore, be it

RESOLVED, that the Niagara County Legislature hereby approves the extension to the agreement between NCHP and Nova extending such engagement to an additional one year period beginning January 1, 2018 to December 31, 2018 on the same terms and conditions as set forth in the previous agreement referenced above, and be it further

RESOLVED, that the Chairman of the Legislature or County Manager is hereby authorized and directed to execute said contract in form and content as reviewed and approved as to legal form by the Niagara County Attorney.



WHEREAS, the New York State Office of Mental Health (OMH) has awarded funding to expand Assertive Community Treatment (ACT) services into Niagara County, and

WHEREAS, Spectrum Human Services goal is to expand Assertive Community Treatment (ACT) services and replicate the ACT services currently funded for Erie County, to reach and provide highly individualized, locally based treatment, rehabilitation, and support services to individuals that have been diagnosed with a serious and persistent mental illness, and who reside in the rural, urban and suburban communities throughout the borders of Niagara County, and

WHEREAS, Spectrum Human Service's purpose is to provide Assertive Community Treatment (ACT) services via an ACT team which strives to lesson or eliminate the debilitating symptoms of mental illness each individual client experiences and to minimize or prevent recurrent acute episodes of the illness, to meet basic needs and enhance quality of life, to improve functioning in adult social and employment roles, to enhance an individual's ability to live independently in his or her own community, and to lessen the family's burden of providing care, now, therefore, be it

RESOLVED, that the following budget modification be effectuated to the department's budget and the department is given authorization to enter into contract with Spectrum Human Services to begin implementation of services effective October 1, 2017:

WHEREAS, the Niagara County Probation Department applied for funding from the New York Division of Criminal Justice Services for a Niagara County Reentry Program for the contract period of October 1, 2017 through September 30, 2018 under the Local Reentry Task Force Initiative for Upstate Counties, and

WHEREAS, the Local Reentry Task Force Initiative is part of a state-wide comprehensive strategy developed under Governor Andrew M. Cuomo and the Division of Criminal Justice Services Executive Deputy Commissioner Michael C. Green, to reduce recidivism in local jurisdictions and increase public safety through improved coordination and collaboration among criminal justice, social services, educational, health and mental health systems, and

WHEREAS, the role of the Niagara County Reentry Program is to provide these coordinated services to high-risk offenders, including housing, employment, education, family support and reunification, substance abuse services, mental and physical health, and other transitional needs, and

WHEREAS, the Niagara County Reentry Program will collaborate with state and county criminal justice agencies, particularly with the Division of Parole and the Niagara County Probation Department, as well as human service providers to develop well-crafted transition plans for high-risk offenders transitioning from prison or jail back into the community, and

WHEREAS, the Niagara County Probation Department has received notification from the New York State Division of Criminal Justice Services of a financial award in the amount of \$111,109 for the period of October 1, 2017 through September 30, 2018 to contract with Community Missions, Inc. to establish and manage a comprehensive parole reentry program, and

WHEREAS, Community Missions, Inc. has been the only agency providing reentry services in Niagara County since 2008, is the only agency able to adequately provide crises housing to the population served by the program, is the only agency with an experienced Reentry Coordinator, and has staff trained and certified to provide the required cognitive behavioral interventions, and

WHEREAS, the provision of the services described above constitute professional services requiring specialized skills and training. Community Missions, Inc., is currently the sole source provider for such services in Niagara County, and





## RESOLUTION IN SUPPORT OF PROTECTION OF THE NIAGARA FALLS AIR RESERVE STATION'S MAIN RUNWAY APPROACHES BY ELIMINATING POTENTIAL HEIGHT OBSTRUCTIONS

WHEREAS, the Niagara County Legislature over the past 20 years has supported the Niagara Falls Air Reserve Station (N.F.A.R.S.) due to its economic and strategic importance to the Niagara Region, and

WHEREAS, the Niagara County Legislature considers N.F.A.R.S. a driving force in improving economic prosperity and the quality of life in Niagara County, and

WHEREAS, N.F.A.R.S. has been contemplated for foreclosure under prior rounds of Base Realignment and Closures (BRAC), ultimately remaining in operation, and the Niagara County Legislature desires to protect N.F.A.R.S from closure under future rounds of BRAC, and

WHEREAS, the Niagara Military Affairs Committee (NiMAC) through the Town of Wheatfield intend to purchase the Property Development Rights (PDR) from current farmland owners to eliminate the construction of any obstacle on the east to west approaches of the main runway, and

WHEREAS, the objective is to compensate active farmers for not turning over building rights to their property, thus eliminating the construction of any obstacle which would constitute an encroachment, while allowing the farmers to continue to operate their farmland in turn for a fair financial compensation, and

WHEREAS, BRAC and the United States Air Force can then be assured of an encroachment free environment, which is so important to the sustainability and growth at the Niagara Falls Air Reserve Station, and

WHEREAS, a land assessment study of the farmland properties contiguous to the Niagara Air Reserve Station and the Niagara Falls International Airport Runway Protection Zone (RPZ), is an important accompaniment to a grant application funded by the New York State Agriculture & Markets Commission, and

WHEREAS, NiMAC has contacted GAR Land Appraiser Company to analyze the farmland approaches to the main runway at an estimated cost of \$30,000, and

WHEREAS, to fund this land assessment, NiMAC and the Town of Wheatfield, have reached an agreement with the Western New York Land Conservancy; who are well recognized and respected by the NY Agriculture and Markets Commission, to identify properties to be appraised, and

WHEREAS, the Western New York Land Conservancy, in conjunction with the NiMAC and the Town of Wheatfield will arrange to engage a land assessment realtor recognized by the NY Agriculture and Markets Commission, and



WHEREAS, this major project is designed to ensure the elimination of encroachments to flight operations at both flying activities, which is a necessary step to survive the next BRAC study of military facilities throughout the United States, and

WHEREAS, to generate the necessary financials, funding was contemplated with the following entities participating:

## RESOLUTION IN SUPPORT OF WILSON HARBOR REVITALIZATION AND REPAIR THROUGH THE USE OF CASINO FUNDING

WHEREAS, the Town of Wilson has devised a multi-year Wilson Harbor Revitalization Project that includes plans to dredge the harbor and restore its navigable channel, and

WHEREAS, Wilson Harbor is the largest naturally protected harbor on the southern shore of Lake Ontario; home to over 500 boats distributed among three yacht clubs and four marinas, and

WHEREAS, New York State's Tuscarora Park flanks the western end of the channel with a boat ramp that averages over 2,000 launches each season, and also hosts a U.S. Customs Port-of-Entry, and

WHEREAS, the eastern end shelters Tuscarora Yacht Club, the Wilson Boat House restaurant and marina, and small boutique shops along a boardwalk, and Mid-harbor features the Moyer Marina, the member-owned and -operated Wilson Yacht Club, and the Sunset Bay Grille, and the southwest end houses the Sunset Bay Marina and the Island Yacht Club, and

WHEREAS, anglers from throughout the Northeast and Ohio Valley routinely travel to the Lake Ontario shore, with sport fishing generating an annual \$30 million annual impact, with more than 1,000 of the regular visitors to restaurants and shops are water-access only, and

WHEREAS, Wilson Harbor is classified as an international harbor of refuge for any vessel in distress and need of assistance on Lake Ontario, regardless of flag origin, and

WHEREAS, natural silting in the lake has adversely impacted the harbor, decreasing the navigability of the channel, and

WHEREAS, this has reduced access to the maintenance yards during the off-season for local and Canadian boats, and has generated an estimated loss of \$100,000-\$200,000 at just one marina, and

WHEREAS, funds are being sought to help offset the costs associated with revitalization of the Wilson Harbor in accordance with the vision set out in the 2012 Revitalization Project study, now, therefore, be it

WHEREAS, under The Second Amendment Guarantee Act states or local governments would not be able to enact restrictions on any part of a rifle or shotgun including any detachable magazine or ammunition feeding devise and any type of pistol grip or stock design, and

WHEREAS, under The Second Amendment Guarantee Act, any current or future laws enacted by a state or political subdivision that exceeds federal law for rifles and shotguns would be void, including the NY SAFE Act, and
