



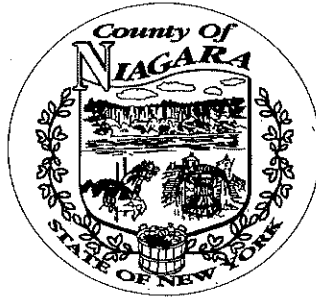

EXTENSION OF CLAIMS ADMINISTRATION CONTRACT BETWEEN THE NIAGARA COUNTY WORKERS' COMPENSATION PLAN MUTUAL SELF-INSURANCE PLAN ("MUSIP") AND OMNI UNDERWRITING MANAGERS LLC, D/B/A FUTURECOMP FROM JANUARY 01, 2023 TO DECEMBER 31, 2023.

WHEREAS, the Niagara County Legislature authorized the signing and delivery of a contract between MuSIP and OMNI Underwriting Managers LLC, d/b/a FutureComp, for the provision of claims administration services for the MuSIP for a twelve (12) month period from January 01, 2022 to December 31, 2022 at an annual fee of \$85,000, billed quarterly (Resolution AD-018-07), and

WHEREAS, OMNI Underwriting Managers LLC, d/b/a FutureComp, has rendered professional and competent services to the County and to the MuSIP pursuant to said, and

WHEREAS, the MuSIP requires, and OMNI Underwriting Managers LLC, d/b/a FutureComp has offered to render, the same professional services set forth in said agreement at the same annual fee of \$85,000 as it charged the MuSIP for the period covered by the previous agreement, now, therefore, be it

WHEREAS, Section XII of the Niagara County Investment Policy authorizes the participation in a cooperative investment program with other authorized municipal corporations pursuant to Article 5-G of the General Municipal Law and in accordance with Article 3-A of the General Municipal Law, with approval from the County Legislature and County Manager, and

WHEREAS, the County Treasurer would like to pursue investments within the NY MuniTrust, a local government investment pool managed by Dreyfus, a division of BNY Mellon, and

WHEREAS, BNY Mellon is an approved bank depository for the County, and

WHEREAS, the NY MuniTrust has two separate investment funds available, the Excelsior Fund exclusive to Counties, and the Empire Fund for municipal corporations, and

WHEREAS, NY MuniTrust meets the requirements set forth by the Niagara County Investment Policy, allowable investments per General Municipal Law 11, and Articles 5-G and 3-A of the General Municipal Law, and

WHEREAS, it is beneficial for the County to have multiple investment options and a diversified portfolio, now, therefore, be it

RESOLVED, that the County Treasurer is hereby authorized to participate in the NY MuniTrust Excelsior and Empire Funds.

WHEREAS, such unanticipated increase in sales tax revenue has led the County to distribute higher than anticipated amounts of revenue to the local municipalities, and

REQUESTING THE ENACTMENT OF A BILL AUTHORIZING AND EMPOWERING THE COUNTY OF NIAGARA TO EXTEND THE ADDITIONAL RATE OF ONE PERCENT SALES AND COMPENSATING USE TAX

WHEREAS, the County of Niagara thereafter deemed it necessary to extend the additional one percent (1%) sales tax, as set forth in Home Rule Message Resolution CW-007-20 adopted March 10, 2020 and imposition resolution CW-018-20 adopted June 16, 2020 to enable the County of Niagara to continue to offset the cost of the local share of mandated Medicaid costs, and

WHEREAS, the extension of the one percent (1%) rate was imposed from the period beginning December 1, 2020 and ending November 30, 2023, and

WHEREAS, the Niagara County Legislature hereby finds that it is necessary to further extend the additional one percent (1%) sales tax for the period beginning December 1, 2023 and ending November 30, 2026 to enable the County of Niagara to continue to offset the cost of the local share of mandated Medicaid costs, now, therefore, be it

RESOLVED, that the Niagara County Legislature requests and urges the New York Senate to work with the New York State Assembly, along with the Governor to enact a bill to authorize the County of Niagara to continue to impose an additional one percent (1%) rate of tax for the period beginning December 1, 2023 and ending November 30, 2026 in addition to the three percent (3%) the County is authorized to impose and to dedicate the funds from the additional one percent (1%) rate to the payment of the local share of Medicaid costs, said authorization in the form of a Senate Bill and an Assembly Bill.

NIAGARA COUNTY YOUTH BUREAU – NEW YORK STATE AID APPLICATION

WHEREAS, the County of Niagara has been designated as eligible to receive State Aid for 2022 youth programs through its Youth Bureau from the New York State Office of Children and Family Services in the amount of \$191,813, \$41,051, \$63,867, and

WHEREAS, the Comprehensive Planning Law mandates the Niagara County Youth Bureau must apply for such funds, and

WHEREAS, prior to the execution of the required documents, the County Attorney will review the documents for approval as to legal form, language and compliance, now, therefore, be it

A RESOLUTION CALLING ON THE STATE OF NEW YORK TO CONTINUE TO PASS-THRU FEDERAL AFFORDABLE CARE ACT ENHANCED FEDERAL MEDICAID ASSISTANCE PERCENTAGE FUNDS

WHEREAS, the SFY 2024 State Budget proposal would end the Affordable Care Act (ACA) enhanced Federal Medical Assistance Percentage (eFMAP) federal pass-thru to counties and New York City, and

WHEREAS, the State is proposing to keep all of these federal savings going forward and use them to cover further expansions of Medicaid eligibility and benefits and to increase payments to health care providers, and

WHEREAS, the elimination of this ACA eFMAP federal pass-thru will require the 57 counties to spend at least \$280 million more in SFY 2024, and approximately \$1 billion when New York City is included, and

WHEREAS, the SFY 2024 costs to counties and New York City are scheduled to grow by 30 percent by SFY 2027, and

WHEREAS, the elimination of this ACA eFMAP federal pass-thru will increase Niagara County's budget by approximately \$6.0 million dollars annually, and

WHEREAS, this State Budget proposal will increase the County property tax levies and have a negative long-term impact on other county services, and

WHEREAS, it is the strong view of New York State Association of Counties (NYSAC) that Congress intended these federal savings to be shared with counties proportional to the amount they contributed toward the nonfederal Medicaid match, and

WHEREAS, since 2003, the state has shared the funds proportionally based on our analysis of savings we have received during periods when an enhanced federal Medicaid match was enacted by Congress, and

WHEREAS, enacted in 2011, the Medicaid statutory cap for all 62 counties is \$7.6 billion. The Medicaid statutory cap for the 57 counties outside of New York City is \$2.25 billion, and

WHEREAS, starting in SFY 2014, New York began sharing these federal ACA savings directly with counties. The savings for a year were provided by lowering the weekly payments each county and NYC make to the state to support the State's Medicaid program. Through February 1, 2023, the state continues to share the federal savings from the ACA eFMAP with the 57 counties and NYC, and

WHEREAS, counties strongly disagree with the need to cut county funding so deeply when the Governor's budget proposes to fully fund its own reserves two years ahead of schedule by depositing \$5.4 billion into reserves before the end of SFY 2023, while also projecting a general fund surplus of \$35 billion by the end of SFY 2024, now, therefore, be it

RESOLVED, that the Niagara County Legislature calls on the State to continue to share these federal funds with counties as has been the precedent for over 20 years, and be it further

RESOLVED, that copies of this resolution to the Governor of the State of New York, the Niagara County Delegation to the New York State Legislature, the New York State Congressional Delegation, and all others deemed necessary and proper.

A RESOLUTION IN OPPOSITION TO THE PROPOSED BAN ON NATURAL GAS HEATING AND APPLIANCES IN NEW YORK STATE

WHEREAS, Governor Hochul's state-of-the-state address contained a proposal to "...end the sale of new fossil powered heating equipment by 2030 by calling for construction of – all new construction needs to be zero emission – starting in 2025 for small buildings and 2028 for large buildings," and

WHEREAS, President Biden and the White House have come out against any prohibition of gas stoves, and

WHEREAS, the State's proposal is intended to help address climate change, but could create a burden for our region's working-class residents, and

WHEREAS, a ban on natural gas appliances and water heaters is not feasible for Western New York with harsh winter weather and exposed electrical infrastructure. Appliances used to heat water and cook food need to work during power outages especially during times of inclement weather, and

WHEREAS, this past December saw a blizzard rip through the Buffalo Metro Area leaving tens of thousands of residents stuck in their home without power, many for several days. Gas appliances, fed by more resilient infrastructure, allowed those residents to heat their homes, boil water, and safely cook their food for the days needed to clear the roads and restore electricity. Nearly four dozen people died during this storm, many more would have suffered if they had to rely on our power grid for cooking and emergency heating, and

WHEREAS, what is more, alternatives to natural gas-powered heating have yet to be proven reliable as a sole-source heating system in cold-weather climates, and

WHEREAS, electrical appliances have more moving parts and are expensive to maintain and repair, mandating their purchase is an unnecessary burden we are placing on families across New York State at a time when the cost of living has significantly outpaced wage growth, and

WHEREAS, currently, due to market conditions and technology limitations, most electric appliances are less efficient and absent improvements in electricity efficiencies and the electrical infrastructure grid, would likely cause increases in energy costs, and

WHEREAS, as we have seen with California's recent push to make everything electric, improperly planned energy transitions can lead to an increased strain on a state's electrical grid, leading to blackouts and rationing, which is especially dangerous with the winter weather we experience, and

WHEREAS, the costs to transition the state's energy infrastructure grid should go through a more thorough review to understand how this will impact the energy production and distribution system as a whole, how it will impact energy costs to consumers and how it will be paid for, before any action is taken, now, therefore, be it

RESOLVED, the Niagara County Legislature opposes the state's plan to ban natural gas heating and appliances as currently drafted, as it does not adequately address concerns about our winter weather conditions, and be it further

RESOLVED, that the Niagara County Legislature urges Governor Hochul and the New York State Legislature to pause on their rush and to fully examine the real life impact their decisions will have for all New Yorkers, especially those least able to afford them, and be it further

RESOLVED, that certified copies of this resolution be forwarded to Governor Hochul's Office, the Western New York Delegation to the New York State Senate and Assembly, and any other party deemed necessary and proper

RESOLUTION CREATING THE AGRICULTURAL RIGHTS ADVISORY PANEL

WHEREAS, Niagara County has a long, proud tradition as an agricultural community that strongly supports the rights of farmers to run their operations free from harassment and with the support of our local governments, and

WHEREAS, agriculture, including related agribusinesses, is one of Niagara County's largest market sectors producing close to \$20 million in products sold annually, and

WHEREAS, at time when there is a global focus on addressing food security and nutrition, it is recognized that local agriculture is tremendously important in addressing these issues, for both personal and public consumption, especially in times of pandemics or natural disasters, and

WHEREAS, in recent years, there seems to be constant efforts in New York State to enact ill-considered legislation and policies by those with little to no understanding of farm economics that is making it increasingly difficult for our local farms to succeed, and

WHEREAS, Niagara County is also not immune to militant ideologies that are seeking to undermine the rights of farmers, attack the livestock industry and provoke confrontation, and

WHEREAS, while Niagara County has consistently passed resolutions opposing such actions, there is a desire to find more concrete ways to support our farmers within the enumerated powers of county government, and

WHEREAS, an Agriculture Rights Advisory Panel is one way to engage with the farming community, and

WHEREAS, such a panel could, among other actions, make recommendations to the Niagara County Legislature for resolutions and local laws, propose process improvements, link with the mainline agriculture organizations like the Farm Bureau, Cornell Cooperative Extension and others, and help promote Niagara County as a place that welcomes and encourages the agriculture industry, now, therefore, be it

RESOLVED, that the Niagara County Legislature creates the Agriculture Rights Advisory Panel, and be it further

RESOLVED, all appointments to the panel are to be made by the Chairman of the Legislature, and all Niagara County Legislators are invited to submit names for consideration.
