A LOCAL LAW AMENDING LOCAL LAW NO. 4 OF 2003 ESTABLISHING AN ADMINISTRATIVE CODE FOR THE COUNTY OF NIAGARA

WHEREAS, the County Legislature of the County of Niagara, enacted Local Law No. 4 of 2003 establishing an Administrative Code for the County of Niagara, and

WHEREAS, the County Legislature of the County of Niagara, amended Local Law No. 4 of 2003 by Local Law No. 1 of 2006, Local Law No. 5 of 2008, Local Law No. 2 of 2011, and Local Law No. 1 of 2015, and

WHEREAS, the County Legislature of the County of Niagara, per Local Law No. 1 of 2015 created the Buildings and Grounds Department and the Infrastructure and Facilities Committee was designated for the oversight and jurisdiction of such Buildings and Grounds Department, and

WHEREAS, the County Legislature of the County of Niagara, designated the County Manager to make the appointment of the Director of Buildings and Grounds Department pursuant to those powers and duties of the County Manager set forth in Section A3-3 (i), and

WHEREAS, the County Manager recommends a restructuring of the Public Works Department so as to merge the Buildings and Grounds Department and Parks/Golf Course Department into the Public Works Department, and

WHEREAS, the Buildings and Grounds Department and Parks/Golf Course Department shall remain as divisions of the Department of Public Works, and

WHEREAS, the division of Buildings and Grounds, and division of Parks/Golf Course shall be under the control of the Deputy Commissioner Public Works for Buildings, Grounds, and Parks, who reports to the Commissioner of Public Works, and

WHEREAS, the County Legislature of the County of Niagara, does hereby amend Local Law No. 4 of 2003 establishing an Administrative Code for the County of Niagara, as amended by Local Law No. 1 of 2006, Local Law No. 5 of 2008, and Local Law No. 2 of 2011, and Local Law No. 1 of 2015 by a Local Law of the County of Niagara, New York for the year 2017 as follows:

ARTICLE II. THE COUNTY LEGISLATURE

§A2-9. Committees of the County Legislature: Jurisdiction, Powers and Duties

A. The jurisdiction of the committees shall be as follows:

- (5) Infrastructure and Facilities
 - (a) Public Works
 - (b) Refuse District
 - (c) Water District
 - (d) Sewer District
 - (e) Weights and Measures
 - (f) Information Technology

A3-3. Powers and Duties

1. Without curtailing, diminishing or transferring the powers of any elected County official, the County Manager shall be responsible for the overall administration of county government and shall provide and coordinate staff services to the County Legislature, Chair of the Legislature and its committees. The County Manager shall perform all the duties now and hereafter conferred or imposed upon the officer by law and directed by the County Legislature and shall have all powers and perform all the duties necessarily implied or incidental thereto. Among such powers and duties, but not by way of limitation, are:

(a) To serve as the Chief Executive and Administrative Director of County Government;

(b) To exercise supervision and control over the activities of County department directors and supervise the administration of all units of County government to most effectively implement the directives of the Legislature in accordance with applicable law, but shall not exercise administrative control over the County Auditor, the County Treasurer, the County Attorney, the District Attorney, the County Sheriff, the Public Defender, the County Clerk, or any other publicly elected official;

(c) To determine which employees of the County shall perform particular duties not clearly defined by law or this Local Law;

(d) To execute and enforce all Local Laws, legalizing acts, ordinances and resolutions of the County Legislature and all other acts required by law;

(e) To serve as an advisor to the County Legislature and develop policy and procedural recommendations for consideration of the Legislature;

(f) To undertake research and submit to the County Legislature reports and recommendations regarding governmental operations as may be deemed appropriate or the County Legislature may request, and provide such assistance to the Legislature and its committees as may be requested by the Legislature;

(g) To serve as liaison between the County Legislature and the boards, commissions, agencies, and advisory committees established by the Legislature;

(h) To maintain liaison and represent the County Legislature in contacts with political subdivisions, State and Federal officials and agencies;

(i) To make appointments for the heads of units of County government listed below, subject to the confirmation of the County Legislature:

- 1. Director of the Office of the Aging
 - 2. Commissioner of Public Works
- 3. Director of Information Technology
- 4. Director of Human Resources
- 5. Director of Employment and Training
- 6. Fire Coordinator and Director of Emergency Services
- 7. Commissioner of Economic Development
- 8 Director of Probation
- 9. Director of Real Property Tax Services
 - 10. Commissioner of Social Services
 - 11. Director of Veterans' Services

PUBLIC HEARING FOR LOCAL LAW AUTHORIZING THE LEASE OF COUNTY OWNED PROPERTY FOR A LEASE TERM IN EXCESS OF FIVE YEARS

WHEREAS, the county of Niagara is the owner of real property no longer necessary for public use located at the intersection of Niagara Street and Sunset Drive, in the town of Lockport, county of Niagara, State of New York, specifically seven (7) acres with a structure with a portion of said seven (7) acres, namely a 1.9 acre parcel off the westerly portion of the leased property, being retained by county of Niagara as the said 1.9 acre parcel will not be leased as it is utilized for the purpose of additional parking for the Niagara County Jail, and

WHEREAS, said seven (7) acres of real property was leased to Fellowship House, Inc. pursuant to a lease agreement entered into on January 1, 1992, by and between County of Niagara and Fellowship House, Inc. for a term of fifty (50) years for the purpose of conducting a youth program for recovering alcoholics/substance abusers, and

WHEREAS, said lease agreement was amended to return the 1.9 acre parcel referenced above to the county of Niagara for the purpose stated above with all of the other terms of the original January 1, 1992 lease agreement remaining in full force and effect; said amended lease agreement by and between county of Niagara and Fellowship House, Inc. was entered into on February 6, 1996, and

WHEREAS, Fellowship House, Inc., ceased to be the organization conducting the youth program for recovering alcoholics/substance abusers, at the above-referenced real property and in accordance with the January 1, 1992 lease agreement and said January 1, 1992 lease agreement was terminated by mutual consent of county of Niagara and Fellowship House, Inc., on April 30, 2016, and

WHEREAS, a new lease agreement was entered into by and between county of Niagara and Cazenovia Recovery Systems, Inc., on May 1, 2016 to conduct a program for female recovering alcoholics/substance abusers and their children, at the said real property and structure referenced above, with said program to be operated and maintained by Cazenovia Recovery Systems, Inc. in accordance with relevant federal and state

laws and regulations, and certified by the State of New York Division of Alcoholism and Alcohol Abuse, and

WHEREAS, said the May 1, 2016 lease agreement was for a term of five (5) years with county of Niagara and Cazenovia Recovery Systems, Inc. having the ability to extend said May 1, 2016 lease agreement for additional five (5) year terms by executing a mutually agreed upon written amendment to the May 1, 2016 lease agreement, and

WHEREAS, the State of New York has informed county of Niagara, by and through its agent the Niagara County Department of Mental Health, that the State of New York desires to renovate the structure located on said real property referenced above with the cost of said renovations being in the amount of \$1,501,000.00, and

WHEREAS, the State of New York is requiring the lease term of the May 1, 2016 lease agreement by and between county of Niagara and Cazenovia Recovery Systems, Inc. to be twenty-five (25) years, instead of the current lease term of five (5) years, and

WHEREAS, New York County Law §215(3) allows the Niagara County Legislature to "... lease for county purposes real property for terms not exceeding five years with the privilege of renewal..."; however, a local law may be adopted by the Niagara County Legislature authorizing the lease by County of Niagara of private property for a County purpose for a term in excess of five (5) years, and

WHEREAS, county of Niagara may provide much needed services for a program for female recovering alcoholics/substance abusers and their children, for Niagara County residents at the said real property referenced above by and through the May 1, 2016 lease agreement with Cazenovia Recovery Systems, Inc., now, therefore, be it

RESOLVED, that the county of Niagara proposes the adoption of the following proposed Local Law:

A Local Law authorizing the lease of County property no longer necessary for public use, commonly described as the real property with structure located at the intersection of Niagara Street and Sunset Drive, in the town of Lockport, county of Niagara, State of New York, specifically seven (7) acres with a portion of said seven (7) acres, namely a 1.9 acre parcel off the westerly portion of the leased property, being retained by county of Niagara for a private lease to Cazenovia Recovery Systems, Inc. for an initial twenty-five (25) year Lease Term, with the privilege of renewal.

Be it enacted by the Legislature of the county of Niagara, New York, as follows:

- 1. That the county of Niagara be allowed to lease certain real property with structure described above inasmuch as said property is no longer necessary for any County public use and inasmuch as the lease of the property will have no environmental significance on the area.
- 2. That the county of Niagara is authorized to conduct private negotiations for the lease of said premises without public bidding.
- 3. That said lease will be for a fair and adequate consideration subject to final approval by the Niagara County Legislature.
- 4. That said consideration would be the annual rent of One Dollar and No Cents (\$1.00) per year by the tenant Cazenovia Recovery Systems, Inc. along with the maintenance.
- 5. That the said leasehold be restricted to allowing Cazenovia Recovery Systems, Inc. to utilize the real property and facilities thereon for the sole purpose of maintaining services for a program for female recovering alcoholics/substance abusers and their children, of Niagara County.

PUBLIC HEARING FOR LOCAL LAW AUTHORIZING THE LEASE OF COUNTY OWNED PROPERTY [I.E. TROTT ACCESS CENTER TO NORTHPOINTE] FOR A LEASE TERM IN EXCESS OF FIVE YEARS

WHEREAS, according to statistics provided by the Centers for Disease Control and Prevention, in 2014, there were 28,647 opioid overdose deaths nationwide, or 78 people per day, and a 14% increase in one year, driven by both prescription opioid abuse and misuse as well as heroin abuse, and

WHEREAS opioid and heroin abuse and addiction impact both rural and urban areas, as demonstrated by the fact that, in the first four months of 2015, there were 27 overdoses, 4 deaths, in the 12 non-urban towns of Niagara County, the City of Niagara Falls alone saw 16 opioid-related overdoses, including 4 fatalities; the City of Lockport saw 11 overdoses, 3 deaths; and the City of North Tonawanda saw 10 overdoses, 3 deaths, and

WHEREAS per a February 9, 2016 news report on WGRZ Channel 2, "the opioid epidemic in Western New York is getting worse...over the course of ten days, 23 people died from suspected overdoses, according to the [Erie County] medical examiner," with the dangerous substance Fentanyl used as a heroin cutter increasing fatalities, and

WHEREAS, the epidemic of heroin and opioid use, abuse and overdose that is plaguing our country is growing in Niagara County. In addition, High Intensity Drug Trafficking Area (HIDTA) officials have indicated that butyryl fentanyl is being seized in Erie and Niagara Counties and the West Coast—and those local cases have increased dramatically in two years' time. The number of deaths has skyrocketed over the last few years and our county must continue to fight against the disease of drug addiction, through coordination with private health care providers in the treatment of this disease, and

WHEREAS, a methadone treatment center has operated at the Trott Building for approximately thirty [30] years and Northpointe Council, Inc. has operated such methadone treatment center for the past seven [7] years; and

WHEREAS, Northpointe Council, Inc. wishes to expand its methadone treatment program in the Trott Building so that it may treat approximately 250 individuals per year rather than the current level of 85 individuals per year; and

WHEREAS, the County of Niagara is the owner of the Trott Building and such building has additional unused space which can be utilized for the expansion of the services offered by Northpointe Council, Inc. so that Northpointe Council, Inc. will occupy an additional 5,327 square feet of space for a total of 9,165 sq. feet of space in the Trott Building, and

WHEREAS, the County of Niagara recognizes the value and importance that Northpointe Council, Inc. plays in the community and its effort to treat individuals addicted to opiates and intends to facilitate the Northpointe Council, Inc. expansion by the commitment of the sum of \$50,000.00 to the expansion of the existing Northpointe Council, Inc. facility in the Trott Building, and

WHEREAS, the City of Niagara Falls recognizes the value and importance that Northpointe Council, Inc. plays in the community and its effort to treat individuals addicted to opiates and intends to facilitate the Northpointe Council, INC. expansion by the commitment of the sum of \$50,000.00 to the expansion of the existing Northpointe Council, Inc. facility in the Trott Building, and

WHEREAS, New York State Senator Robert G. Ortt, recognizes the value and importance that Northpointe Council, Inc. plays in the community and its effort to treat individuals addicted to opiates and intends to facilitate the Northpointe Council, Inc. expansion by the commitment of the sum of \$100,000.00 of New York State funding to the expansion of the existing Northpointe Council, Inc. facility in the Trott Building, and

WHEREAS, said lease of a total of 9,165 sq. feet of space in the Trott Building by Northpointe Council, Inc. will be for four [4] successive five [5] year terms for a maximum term of twenty (20) years for the purpose of conducting a methadone treatment center, and

WHEREAS, New York County Law §215(4) allows the Niagara County Legislature to lease county real property not required for public use "for a term not exceeding five years upon such terms and conditions as may be prescribed by the board in the same manner and with the same rights and privileges as if owned by an individual."; however, a local law may be adopted by the Niagara County Legislature authorizing such lease for a term in excess of five (5) years, now, therefore, be it

RESOLVED, that the County of Niagara proposes the adoption of the following proposed Local Law:

A Local Law authorizing the lease of County property no longer necessary for public use, that being an additional 5,327 square feet of space for a total of 9,165 sq. feet of space in the Trott Building to the Northpointe Council, Inc. for an initial five (5) year Lease Term, with the privilege of three [3] five [5] year renewals, for a maximum lease term of twenty [20] years.

Be it enacted by the Legislature of the County of Niagara, New York, as follows:

1. That the County of Niagara be allowed to lease certain real property described above in an much said property is no longer necessary for any County public use.

2. That the County of Niagara is authorized to conduct private negotiations for the lease of said premises without public bidding.

3. That said lease will be for a fair and adequate consideration subject to final approval by the Niagara County Legislature.

4. That said consideration would be the initial annual rent of \$122,811.00 per year by the tenant Northpointe Council, Inc.

5. That the said leasehold be restricted to allowing Northpointe Council, Inc. to utilize the real property and facilities thereon for the sole purpose of maintaining a methadone treatment center in Niagara County.

6. That Niagara County will may make alterations, additions or improvements to the premises for Northpointe Council, Inc. at the approximate cost of \$200,000.00 prior to the occupancy by Northpointe Council, Inc.

7. Any alterations, additions or improvements to the premises under the leasehold shall revert to the County of Niagara at the end of the Lease Term.

8. That the chairman of the Niagara County Legislature execute all documents necessary to effectuate such lease, including, but not limited to, contracts with Northpointe Council, Inc. and any governmental agency providing funding for any renovations or improvements to the facilities on said real property for the operation of a methadone treatment center, after review and approval by the County Attorney.

9. That the property to be leased is described as follows:

Real property located at the City of Niagara Falls, County of Niagara, state of New York, specifically a total of 9,165 sq. feet of space in the Trott Building as more particularly described in the lease, and be it further

RESOLVED, that the Niagara County Legislature shall conduct a public hearing upon said proposed Local Law at the Legislative Chambers, Niagara County Courthouse, Lockport, New York, on the 20th day of June, 2017 at 6:00 p.m., and be it further

RESOLVED, that the Clerk of the Legislature, a least six days in advance of such hearing, shall post a notice upon the bulletin boards in the Courthouse at Lockport, and the Civic Building at Niagara Falls, and shall publish such notice in the Lockport Union Sun & Journal and the Niagara Gazette; such notice shall contain the title of the Local Law and an abstract of the text to be prepared by the Clerk of the Legislature, with the assistance of the County Attorney's Office.

RESOLUTION SUPPORTING WALLENDA WALK 5-YEAR ANNIVERSARY HELICOPTER SPECTACLE AND APPROPRIATING FUNDING TO ENHANCE PROMOTION AND PUBLIC ACCESS TO THE SAME

WHEREAS, Mr. Nik Wallenda, who on June 15th, 2012, did perform the televised traversing of Niagara Falls on a high-wire, setting the Guinness World Records officially-recognized record as the first person to walk a tightrope stretched directly across Niagara Falls, a death-defying 1,800-foot walk, and

WHEREAS, this televised stunt, which entailed not only traversing one of the Seven Natural Wonders of the World, but also an international border, did capture the attention of the world, with a study by Enigma Research estimating that more than one billion people had either watched or heard about Wallenda's walk, with 13.3 million Americans watching the ABC network broadcast according to Nielsen Ratings data, the most-watched program of the night, and the highest rated Friday night program in five years and the highest non-sports summertime broadcast on any network in six years, and

WHEREAS, ABC secured a 36% lead over its nearest competitor in total viewership and an 88% lead among the key 18-49 age demographic for the week, with a local 67 share in the Buffalo-Niagara market, and a similarly large 50.4 share in the Toronto media market, and

WHEREAS, the Enigma Research study suggests an economic impact of \$21.5 million or more, and the Niagara University Hospital Training and Research Center tallied \$3.3 million in direct revenues to the City of Niagara Falls, with 38,000 visitors on the American side of the Falls alone, with 41% being identified as from out-of-town, and

WHEREAS, the Niagara Tourism and Convention Corp. did report that Niagara Falls area hotel bookings rose an additional 30% above average for the two weeks following the walk, while Smith Travel Research found that June hotel occupancy in Niagara Falls rose from 76.5% in 2011 to 81.6% in 2012, and

WHEREAS, Mr. Wallenda and The Flying Wallendas have proposed a new spectacle on the fifth anniversary of the Walk, to be performed by his wife, trapeze aerialist Erendira Vasquez Wallenda, who will be transported into the air by a helicopter, holding on by her teeth, which would be even more dramatic than Mr. Wallenda's own most notable helicopter stunt, hanging from a trapeze mounted under a helicopter above Silver Dollar City in Branson, Missouri, and

WHEREAS, the Legislature is fully cognizant both of the potential costs associated with high-profile stunt spectacles and the previously-stated opportunities to generate local revenue and economic development benefit, and

WHEREAS, this Legislature seeks to partner with the City of Niagara Falls to ensure the success of Erendira Wallenda's proposed helicopter stunt, now, therefore, be it

RESOLVED, that the Niagara County Legislature does hereby appropriate \$35,000.00 of Bridge Commission funds to be disbursed to such operational entity as The Flying Wallendas shall establish for the completion of Erendira Wallenda's proposed helicopter spectacle, with such funds being allocated via the existing community beautification account, and be it further

RESOLVED, that disbursal of such funding shall be contingent upon an appropriation of like amount by the City of Niagara Falls, and be it further
