PUBLIC HEARING FOR THE AUTHORIZATION TO SUBMIT A GRANT APPLICATION TO THE NEW YORK STATE OFFICE OF COMMUNITY RENEWAL FOR SMALL CITIES FUNDING

WHEREAS, Bridgestone APM Company (the "Company") plans to establish a new manufacturing facility at Vantage Industrial Point in the Town of Wheatfield for the production of polyurethane seat foam for the automotive industry (the "Project"), and

WHEREAS, The Company has requested that the County apply for funding on its behalf from the New York State Office of Community Renewal (the "OCR") to finance a portion of the cost of machinery and equipment to support the Project, and

WHEREAS, the Project will result in substantial benefit to the County in form of an estimated 60 new permanent full-time employment positions upon its opening, now, therefore, be it

RESOLVED, that the Legislature hereby calls for a public hearing to allow citizen input regarding the community development and housing needs in the County and to comment on the County's potential submission of a grant application to assist in the construction of a manufacturing facility in the Town of Wheatfield to the New York State Office of Community Renewal, such public hearing to be held at 6:30 PM on September 15, 2015 in the Niagara County Legislative Chambers, Niagara County Courthouse, 175 Hawley Street, Lockport, NY 14094, and be it further

RESOLVED, that the Clerk of the Legislature, at least six days in advance of such hearing, shall post a notice upon the bulletin boards in the Courthouse at Lockport, the Civic Building at Niagara Falls and shall publish such notice in the Lockport Union Sun and Journal and the Niagara Gazette.
