



## **DISTRIBUTION OF OCTOBER THROUGH DECEMBER 2015 CASINO REVENUE TO VARIOUS MUNICIPALITIES**

WHEREAS, a Seneca Nation gambling casino governed by the Tribal-State Class III Gaming Compact and disbursing monies according to provisions of Subdivision 3-a of the Upstate New York Gaming and Economic Development Act continues to operate Class III gaming activities within the County of Niagara, and

WHEREAS, said casino is operated and owned by the Seneca Nation of Indians, a sovereign and foreign nation which is not subject to any taxation by the County of Niagara, and

WHEREAS, the Tribal-State Class III Gaming Compact and its authorizing legislation, provide for compensation for the "host municipalities" of the Seneca Niagara Casino and said Compact was submitted to and approved by the Secretary of the Interior of the United States as required, and

WHEREAS, pursuant to the Upstate New York Gaming and Economic Development Act, a special separate revenue account denominated "Tribal-State Compact Revenue Account" was established in the joint custody of the State Comptroller and the State Commissioner to receive the gaming revenues payable to the State and the host municipalities, and

WHEREAS, per the provisions of Subdivision 3 of the Upstate New York Gaming and Economic Development Act, 25% of revenues arising from the Seneca Niagara Casino are disbursed to the City of Niagara Falls, and

WHEREAS, per the provisions of the Update New York Gaming and Economic Development Act Subdivision 3-a, "Ten Percent of any of the funds actually received by the state pursuant to the tribal-state compacts and agreements described in [subdivision 2 of the Upstate New York Gaming and Economic Development Act] prior to the transfer of moneys to the general fund required by such subdivision, shall be distributed to counties in each respective exclusivity zone provided they do not otherwise receive a share of said revenues pursuant to [the Upstate New York Gaming and Economic Development Act]; Such distribution shall be made among such counties on a per capita basis, excluding the population of any municipality that receives a distribution pursuant to [Subdivision 3 of the Upstate New York Gaming and Economic Development Act]," and

WHEREAS, per the Upstate New York Gaming and Economic Development Act Subdivision 3-a, revenues arising from the Seneca Niagara Casino that are disbursed to the County of Niagara are to be apportioned by population for such purposes as shall benefit the residents of the Towns of Cambria, Hartland, Lewiston, Lockport, Newfane, Niagara, Pendleton, Porter, Royalton, Somerset, Wheatfield and Wilson, and the Cities of Lockport and North Tonawanda, and

WHEREAS, the Niagara County Treasurer's Office and the Niagara County Office of Management and Budget jointly established two interest-bearing revenue accounts, which shall be designated "Niagara County Community Development Fund 1" and "Niagara County Tax Relief Fund," with all revenues appropriated to



the county under Upstate New York Gaming and Economic Development Act Subdivision 3-a divided and deposited into said accounts, with 25% of said monies being deposited in Niagara County Community Development Fund 1 and 75% of said monies being deposited in Niagara County Tax Relief Fund, with these percentages of distribution remaining in force until December 31, 2015, and

WHEREAS, in December of 2014, this body did vote on a resolution creating both the Niagara County Community Development Fund and the Niagara County Tax Relief Fund, and

WHEREAS, Niagara County has received \$164,728.37 for the period of October 1, 2015 through December 31, 2015 towards the Niagara County Tax Relief Fund, and will distribute the funds to the respective municipalities per the aforementioned formula, now, therefore, be it

RESOLVED, that the Niagara County Legislature does hereby approve the disbursement of the balance in the Niagara County Tax Relief Fund of \$114,638.27 for the period of October 1, 2015 through December 31, 2015, inclusive of necessary prior period adjustments, to the following municipalities within the County of Niagara:

## NIAGARA COUNTY COMMUNITY COLLEGE LEARNING COMMONS PROJECT

WHEREAS, by resolution dated June 16, 2015 and numbered IL-078-15 of the Niagara County Legislature, the Legislature formally committed to fund its matching share of \$10,000,000 to the cost of the Niagara County Community College "Learning Commons" project, and

WHEREAS, resolution AD-008-16 approved the issuance of debt up to \$10,000,000 to finance the County's portion of the cost of the improvements to Niagara County Community College "Learning Commons" project, and

WHEREAS, Niagara County Community College has already begun the planning of this construction using the College's share of the funding and has agreed to complete all requests for proposals and bids necessary and oversee the administration and completion of the project, and

WHEREAS, the College has agreed to submit monthly progress reports to the County Deputy Commissioner of Engineering, and

WHEREAS, a capital project is necessary to track payments made to the College, and verify the total project cost to the County does not exceed the \$10,000,000 authorized by this Legislature, now, therefore, be it

RESOLVED, that the Niagara County Treasurer is authorized to remit payments to NCCC during the life of the project as deemed appropriate by the County Treasurer as percentage of completion milestones are met, as reviewed and approved by the County Deputy Commissioner of Engineering for the construction of the Learning Commons, and be it further

RESOLVED, that the following capital project be created with funding from the bonds previously authorized, and that the following budget modification be effectuated:

## CONVERSION OF REFUSE DISPOSAL DISTRICT FROM A PROPRIETARY ENTERPRISE TYPE FUND TO A GOVERNMENTAL FUND

WHEREAS, the Refuse Disposal District was created by Legislative Order dated January 21, 1969, and

WHEREAS, the Refuse Disposal District has historically been treated as a proprietary, enterprise type fund due to the original nature of its business as an operating landfill site, and

WHEREAS, Generally Accepted Accounting Principles (GAAP) and the Governmental Accounting Standards Board (GASB) state that proprietary funds are used to account for a government's activities that are similar to businesses found in the private sector, are considered self-supporting in that the services rendered are by them are generally financed through user charges or on a cost reimbursement basis. Proprietary enterprise type funds are used to account for any activity for which a fee is charged to external users for good or services, in the context of the activity's principal revenue sources, and

WHEREAS, the District discontinued operations as an active landfill in June of 2013 by resolution PW-071-13 and has since been primarily funded by property taxes, and

WHEREAS, the County's independent auditors recommended via the 2014 audit management letter to establish a governmental, special district fund in which to account for the transactions of the Refuse Disposal District, therefore be it

RESOLVED, that the Niagara County Legislature does hereby approve the conversion of the Refuse Disposal District from a proprietary enterprise type fund to a governmental fund.

## A LOCAL LAW INCREASING THE SALARY OF NIAGARA COUNTY DEPUTY DISTRICT ATTORNEY

WHEREAS, the Administration Committee presents in writing the following proposed Local Law:

A Local Law of the County of Niagara, New York for the year 2016 increasing the salary of the Niagara County Deputy District Attorney;

Be enacted by the County Legislature of the County of Niagara, as follows:

1. During the term of a vacancy in the office of the Niagara County District Attorney, the attorney designated to perform the functions and duties of the Niagara County District Attorney during such vacancy shall receive the same compensation as the elected Niagara County District Attorney would have been entitled to receive.

2. On March 22, 2016, the date of the resignation of the Niagara County District Attorney, the salary established for the Niagara County District Attorney was \$152,500.00; effective April 1, 2016 the salary of the Niagara County District Attorney was increased to \$183,400.00 by operation of law due to the increases in salaries of the County Court Judges of the State of New York. [See Judiciary Law 183-a];

3. Prior to his resignation, the elected Niagara County District Attorney designated a particular Niagara County Deputy District Attorney to perform the functions and duties of the Niagara County District Attorney during his absence and/or a vacancy in such office, therefore, such designated Niagara County Deputy District Attorney shall receive a salary of \$152,500.00, effective March 22, 2016; and effective April 1, 2016 the salary of the Niagara County District Attorney shall be increased to \$183,400.00 during the period of a vacancy in the office of the Niagara County District Attorney.

This Local Law shall become effective in accordance with the statutes of the State of New York.

RESOLVED, that the Niagara County Legislature shall conduct a public hearing upon said proposed Local law at the Legislative Chambers, Courthouse, Lockport, New York on the 21<sup>st</sup> day of June, 2016 at 6:30 p.m., and be it further

RESOLVED, that the Clerk of the Legislature, at least six (6) days in advance of such hearing, shall post a notice upon the bulletin boards in the Courthouse in Lockport, the Civic Building in Niagara Falls shall publish such notice once in the Union Sun & Journal, and the Niagara Gazette; such notice shall contain the title of the Local Law and an abstract of the text to be prepared by the Clerk of the Legislature, with the assistance of the County Attorney's Office.



WHEREAS, the Lockport Community Market, located on Historic Canal Street, will be celebrating its 6<sup>th</sup> season in 2016, and

WHEREAS, the Lockport Community Market is a wonderful venue for local farmers to sell their fruits and vegetables and to educate the public about the benefits of buying locally grown produce, and

WHEREAS, this season's community market is set to expand by three weeks, and will now run every Saturday from June 8 to October 18, offering fresh produce, butchered meat, and banked goods, as well as free sessions of yoga, music, and activities for the children, just to name a few, and

WHEREAS, the 2015 community market featured 72 vendors from throughout Western New York and drew in excess of 10,000 visitors to downtown Lockport, and anticipates both figures growing again, for the sixth consecutive year, and

WHEREAS, the Lockport Community Market brings people into the City of Lockport each week during the season which benefits many local shops, restaurants and businesses throughout the downtown area, and draws tourists and tourism-derived revenue, which benefits the region as a whole, and

WHEREAS, the 2015 Lockport Community Market expended \$12,195 on costs including advertising, professional market management, printing and signage, entertainment, web design, supplies, and yoga instruction, coming in below the targeted budget, and

WHEREAS, the 2016 Lockport Community Market's proposed budget is \$12,131, now, therefore, be it

## RESOLUTION ENDORSING NIAGARA COUNTY COMMUNITIES' APPLICATIONS FOR WESTERN NEW YORK REGIONAL ECONOMIC DEVELOPMENT COUNCIL DOWNTOWN REVITALIZATION INITIATIVE GRANT APPLICATIONS

WHEREAS, New York State's Regional Economic Development Councils are each holding a competitive application process for a \$10 million Downtown Revitalization Initiative grant to be awarded to a single community in each region deemed "ripe for development" into "vibrant communities where tomorrow's workforce will want to live, work and raise families," and

WHEREAS, the Western New York Regional Economic Development, of which the Honorable Wm. Keith McNall, chairman of this Legislature, is a member, has issued a Downtown Revitalization Grant application, and

WHEREAS, four Niagara County communities have indicated an intent to move forward with applications for the Western New York Regional Economic Development Council's Downtown Revitalization Initiative, and

WHEREAS, the applications submitted by Niagara County communities are synopsisized by those respective communities' economic development agencies as follows:

City of Lockport: The City of Lockport's Downtown Revitalization Initiative builds upon the recent economic development successes in downtown Lockport, such as progress at Harrison Place, the continued restoration of the Flight of Five locks, and the construction of Cornerstone CFCU Arena. The nomination request highlights the potential for an even greater impact on Lockport, Niagara County, and throughout the Western New York region by enhancing existing assets in the City's downtown, like The Historic Palace Theatre and vacant and under-utilized mixed-use properties;

City of Niagara Falls: The City of Niagara Falls is targeting the area north of Niagara Street to create a vibrant, year-round downtown district. Major projects like the Seneca Niagara Casino, expansion of Niagara Falls Memorial Medical Center, NCCC's Culinary Institute, construction/renovation/expansion of new hotels have been completed in recent years resulting in creation of new jobs. This trend will only continue as there are other projects in the pipeline to continue the diversification of the Niagara Falls economy. Projects like Housing Visions and the Market Rate Rental Rehabilitation program have begun to create an attractive livable community for diverse populations. The city's 2009 Master Plan has laid a framework of policies that will allow Niagara Falls to integrate continued growth through the DRI;

City of North Tonawanda: The City of North Tonawanda's nomination for the Downtown Revitalization Initiative, known as the NT Momentum project, is the culmination of ten years of comprehensive planning focused on North Tonawanda's historic downtown. This initiative will catalyze development in North Tonawanda along the Niagara River and Erie Canal waterfronts



anchored by a historic downtown filled with culture, arts, recreation, tourism, and a great atmosphere in which to live and work. Focused on leveraging strong local assets, this project will bring new investment to North Tonawanda and spark resurgence in downtown. The Downtown Revitalization Initiative is the opportunity to implement the NT Momentum project and bring the communities downtown redevelopment vision to reality;

Transit North: The Transit North – Historic Canalway Corridor Downtown Revitalization Project brings together three Niagara County communities, the Towns of Lockport and Pendleton and the City Lockport, who are seeking to revitalize the six-mile Transit North

corridor which commences at Tonawanda Creek Road and terminates at the intersection of Main and Washburn Streets in the City of Lockport, and has average daily traffic counts of 29,250. The historic-themed retail shopping district will not only lead to the development of a gateway that creates a sense of arrival and a place worth remembering, but will also help drive business back onto Main Street in the City of Lockport, and

WHEREAS, it is the judgment of the Niagara County Center for Economic Development that these applications are of similar weight and value, and are in line with the vision for development set forth in the Niagara County Comprehensive Plan, and

WHEREAS, this Legislature is prepared to support implementation efforts by any Niagara County community awarded the Downtown Revitalization Initiative grant, now, therefore, be it

RESOLVED, that the Legislature of the County of Niagara does hereby endorse the Downtown Revitalization Initiative grant applications of the City of Lockport, the City of Niagara Falls, the City of North Tonawanda, and the Transit North consortium, and be it further
