A Local Law No. 4 of the County of Niagara, New York,  
for the year 1966, exempting real property tax of persons over age  
65 to be effective immediately.

Be it enacted by the Board of Supervisors of the County  
of Niagara as follows:

1. The provisions of Section 466 of the Real Property Tax Law are hereby enacted and given full force and effect and shall take effect so that the tax exemptions granted therein will be applicable for the 1968 County Tax year and subsequent years.
2. The exemption of assessed valuation of real property included under this Local Law shall be to the extent of fifty per centum thereof.
3. The Board of Supervisors may take such other and further action to implement the provisions of Section 467 of the Real Property Law and this Local Law by resolution.


