Be it enacted by the NIAGARA COUNTY LEGISLATURE of the

1. The salary of the County Treasurer shall be increased in the sum of \$900, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the County Treasurer shall be \$18,750.
2. The salary of the Public Defender shall be increased in the sum of \$450, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the Public Defender shall be \$13,233.
3. The salary of the Commissioner of Social Services shall be increased in the sum of \$900, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the Commissioner of Social Services shall be \$21,025.
4. The salary of the County Attorney shall be increased in the sum of \$450, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the County Attorney shall be \$17,790.
5. The salary of the Commissioner of Jurors shall be increased in the sum of \$387, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the Commissioner of Jurors shall be \$5,545.
6. The salary of the Commissioners of Election shall be increased in the sum of \$832 each, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of each of the Election Commissioners shall be \$11,925.
7. The salary of the Probation Director shall be increased in the sum of \$900, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the Probation Director shall be \$18,261.
8. The salary of the Director of Real Property Tax Services shall be increased in the sum of \$900, effective 45 days after adoption of this local law. Effective January 1, 1976, the annual salary of the Director of Real Property Tax Services shall be \$13,355.
