1. The salary of the County Attorney shall be increased in the sum of \$1,075, effective January 1, 1979. The annual salary of the County Attorney shall be \$22,575.
2. The salary of the Public Defender shall be increased in the sum of \$850.00, effective January 1, 1979. The annual salary of the Public Defender shall be \$17,850.00.
3. The salary of the County Auditor shall be increased in the sum of \$827.00, effective January 1, 1979. The annual salary of the County Auditor shall be \$17,363.
4. The salary of the Purchasing Director shall be increased in the sum of \$863.00, effective January 1, 1979. The annual salary of the Purchasing Director shall be \$18,115.
5. The salary of the Director of Real Property Tax shall be increased in the sum of \$717.00, effective January 1, 1979. The annual salary of the Director of Real Property Tax shall be \$15,055.
6. The salary of the Commissioner of Public Health shall be increased in the sum of \$1,981.00, effective January 1, 1979. The annual salary of the Commissioner of Public Health shall be \$41,593.
7. The salary of the County Treasurer shall be increased in the sum of \$1,050.00, effective January 1, 1979. The annual salary of the County Treasurer shall be \$22,050.
8. The salary of the Commissioner of Parks and Recreation shall be increased in the sum of \$763.00, effective January 1, 1979. The annual salary of the Commissioner of Parks and Recreation shall be \$16,027.
9. The salary of the Probation Director shall be increased in the sum of \$1,072.00 effective January 1, 1979. The annual salary of the Probation Director shall be \$22,511.
10. The salary of the Commissioners of Civil Service shall be increased in the sum of \$118.00 each, effective January 1, 1979. The annual salary of the Commissioners of Civil Service shall be \$2,481.00.
11. The salary of the Commissioners of Election shall be increased in the sum of \$728.00 each, effective January 1, 1979. The annual salary of the Commissioners of Election shall be \$15,277.

This Local Law shall become effective 45 days after the adoption of same.
