Section 1. The purpose of this law is to provide as an exemption from real property taxes levied for the County of Niagara the same proportion of exemption which heretofore existed under Real Property Tax Law, Section 458 prior to the completion of the full value reassessment program in the County of Niagara.

Section 2. Pursuant to the provisions of subdivision 5(b) of Section 458 of the Real Property Tax Law of the State of New York, an exemption from Niagara County real property taxes in the same proportion to total assessed value as was heretofore granted prior to the completion of the full value revaluation program in the County of Niagara is hereby granted by the County of Niagara.

Section 3. This Local Law shall take effect immediately upon its filing with the Secretary of State.
