A local law PROVIDING ADDITIONAL RETIREMENT CREDIT FOR COUNTY EMPLOYEES WHO ARE ELIGIBLE

of NIAGARA as follows:

Section 1. The Legislature of Niagara County finds that it is in the best interest of the County to provide additional retirement service credits pursuant to Chapter 178 of the Laws of 1991 to those employees who are eligible therefore and who file an application for service retirement as specified therein.

Section 2. The County of Niagara shall participate in the Retirement Incentive Program established by the State Legislature for those employees eligible to take part in such Program pursuant to Chapter 178 of the Laws of 1991 and who file an application for service retirement as specified therein.

Section 3. The commencement date of the Retirement Incentive Program shall be September 1, 1991. The open period for the Program as defined by the State Legislation, shall be forty-five (45)- days in length.

Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this Local Law shall be funded over a five-year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State Employee's Retirement System, and it shall be paid by the County of Niagara for each employee who receives the retirement benefits payable under this Local Law.

Section 5. The Local Law shall be effective upon the filing of this law with the Secretary of State.

This Local Law shall become effective immediately.


