1. That Niagara County contribute the sum of \$20,000 as part of a multi-government and private sector effort to establish a new level of public safety on Military Road near LaSalle Senior High School by installing a traffic control device (signal light).

2. This resolution is adopted solely to assist financially in the placement of a traffic control device which the County of Niagara will not be responsible for, before or after installation, and with the express understanding that this resolution does not and will not impute any liability or duty upon the County of Niagara in reference to any act, event, accident or injury occurring prior to or subsequent to the placement of this device.

This Local Law shall become effective immediately upon filing with the Secretary of State.




