A LOCAL LAW ELECTING AN EARLY RETIREMENT INCENTIVE PROGRAM AS AUTHORIZED BY CHAPTER 47 OF THE LAWS OF 1998 FOR THE ELIGIBLE EMPLOYEES OF THE COUNTY OF NIAGARA

Section 1. The County of Niagara hereby elects to provide all of its eligible employees with a retirement incentive program authorized by Chapter 47 of the Laws of 1998.

Section 2. The commencement date of the retirement incentive program shall be October 5, 1998, and extend to December 30, 1998, in which eligible employees may retire and receive the additional retirement benefit.

Section 3. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be paid as one (1) lump sum or in five (5) annual installments. The amount of the annual payment shall be determined by the actuary of the New York State and Local Employees' Retirement System, and it shall be paid by the County of Niagara for each employee who receives the retirement benefits payable under this local law.

Section 4. The County of Niagara hereby establishes an Attrition Policy, whereby any incumbent who retires under the benefits of this program, his or her position shall be reviewed for abolishment by the relevant committee in order to enhance savings pursuant to this program.

Section 5. This act shall take effect August 4, 1998.




