**AMENDMENT OF LOCAL LAW NO. 7 OF 1998 IN RELATION
TO THE REGULATION OF SMOKING IN NIAGARA COUNTY**

Section 4. Regulation of Smoking in Public Places is amended to add the following provision:

Section 4. Regulation of Smoking in Public Places

- b. All Public Places are encouraged to immediately provide a smoke free environment; however, smoking may be permitted, with certain limitations as provided in various sections of this Local Law including, but not limited to, Separate Smoking Rooms or in the following areas and locations:
 - 7. Bingo Halls. The organizer or sponsor of bingo shall provide a contiguous non-smoking area sufficient to meet patron demand if at least fifty (50%) percent of seating capacity is designated for non-smokers. Demand shall be deemed to have been met. The organizer or sponsor may not determine that no such demand exists. Notice shall be prominently posted at each entrance stating that a non-smoking section is available.


