Mr. Cronin stated the Town of Norwood returned a \$112,500 award and will request the funds for a different project. Commissioner Staiti stated he presented an ARPA award check to the Town of Canton last evening.

Chairman Shea announced there are no bid openings at 1:30 pm as detailed in Exhibit A.

Chairman Shea announced there are no contract awards as detailed in Exhibit B.

Mr. Cronin discussed the FY23 Third Supplemental Budget. Commissioner Staiti recommended considering the proposal at the end of the meeting.

Patrick Higgins, PLS, discussed requests for Engineering Department services from the Town of Dover and the Town of Dedham. He stated the Engineering Department has the capability to complete both projects.

Quarterly Meeting notice

Chairman Shea stated the Norfolk County Commissioners meet more than 50 times a year, exceeding the quarterly meetings required by statute.

Mr. Cronin stated the accompanying memo indicates the Tuesday quarterly meetings are postponed to the following Wednesday.

A motion was made by Commissioner Staiti, seconded by Commissioner Collins and

VOTED: To postpone the December 28, 2022 quarterly meeting

Mr. Cronin presented the Report of the County Director. Mr. Cronin stated he attended the opioid settlement meeting in Canton.

He stated Mr. Galvin reached out to Barnstable County to discuss elderly service programs.

Mr. Cronin stated staff interviewed the final custodian candidate this week. He stated there are four Facilities Maintenance staff on extended leave. Mr. Cronin stated staff will examine solutions to deal with the matter.

Commissioner Staiti stated he attended the opioid settlement meeting in Canton and the meeting was productive and well-received.

Mr. Cronin discussed the FY23 Supplemental Budget. He stated on September 22 the Register of Deeds submitted a letter requesting a transfer from deeds excise to fund legal services. Mr. Cronin stated the Register's \$75,000 request is included in the supplemental. Register O'Donnell stated he made the request in September and that he wrote a letter on December 15 stating it is unfair to expect counsel for the Registry to work on mediation and not get paid. He stated the argument is about fairness. Commissioner Staiti stated he would like to see the matter resolved. Commissioner Staiti asked if the Register's prior appropriation was expended. Register O'Donnell stated Commissioner Staiti would have to check with the Treasurer's Office.

Mr. Cronin stated the Register originally asked for \$75,000 for legal services in September and the Register is refreshing that request now in the current supplemental appropriation. Commissioner Staiti stated the Register is looking for funds to go forward in mediation. Chairman Shea stated the Register has encumbered but has not spent the \$20,000 appropriation from September. Chairman Shea asked if there was a reason the Registry of Deeds has not spent the \$20,000. He stated the Commonwealth supplies the mediator. Register O'Donnell stated the monies are for legal fees and services are being expended. Commissioner Collins asked why the Register does not spend the \$20,000 first. Commissioner Staiti stated the Register could get a bill that wipes out his legal account.

Commissioner Staiti made a motion to approve \$25,000 of the requested \$75,000 for Register of Deeds legal services only upon exhaustion of the previously appropriated \$20,000 only to be used on a contingent basis. Chairman Shea seconded the motion for discussion purposes only.

Chairman Shea stated he expected the \$20,000 to be exhausted. Commissioner Collins stated the \$20,000 is still sitting unspent in the Registry budget. Commissioner Staiti withdrew his motion.

A motion was made by Commissioner Staiti, seconded by Chairman Shea and

VOTED: To grant the Register of Deeds the sum of \$10,000 of the requested

Commissioner Staiti voted "yes"

Chairman Shea voted "yes"

Chairman Shea announced the motion passes 2-1.

Mr. Cronin discussed the Supplemental Appropriation. He stated the County proposes a supplemental appropriation and there are five associated motions. Mr. Cronin stated after September's budget adjustment the County had \$451,916 remaining in surplus. He stated moments ago the Commissioners voted to revise the Registry legal fees from \$75,000 to \$10,000. Mr. Cronin stated Agricultural School (NCAHS) items are funded from school surplus. He stated the total amount of the supplemental appropriation is \$1,325,925.71.

Mr. Cronin stated the Commonwealth approved the Wollaston Recreational Facility earmark and the County is pursuing those funds to put back into the County budget. He stated today's supplemental appropriation includes transfers related to collective bargaining, salary increases. Mr. Cronin stated the weights and measurers program is offset by defunding the Dedham District Court generator project. He stated NCAHS has a series of transfers to fund an upcharge on a pickup truck.

Mr. Cronin stated the Commissioners were notified of a Retirement Board vote that will add an additional \$400,000 to County expenses over the next six years.

Commissioner Staiti asked why NCAHS is not pursuing the cafeteria study. John Wallace, NCAHS Business Manager, stated NCAHS needs further discussions to do the study properly. Commissioner Staiti stated the NCAHS Trustees had a feeling that the study was moving forward. He stated there should have been discussions on the matter. Mr. Wallace stated school management decided to withdraw the study.

Mr. Cronin stated there are five motions in total. He stated the motions include a 2.75% COLA adjustment for non-union employees and excludes the Registry of Deeds union.

Register O'Donnell stated the County put a camera in a parking lot to make sure Mr. Cronin's car does not get scratched. Mr. Cronin stated Register O'Donnell's conduct is conduct unbecoming of an elected official. He stated there is a long history of discussion with the Registry regarding IT and the CIO.
