TOWNSHIP ADMINISTRATION

Miss Julie Donnan, legal counsel with Brosius, Johnson & Griggs, provided an update on regulating parking on township roadways. According to Ms. Donnan, the Township has the authority to enact parking restrictions on township roadways. Most Townships have gone the criminal route because it is cost prohibitive to pursue the civil route. Based upon a review by the Franklin County Municipal Court, there have been some hiccups identified in the ORC 505.17 criminal process. Therefore, the matter of what the criminal process looks like has been placed on pause. If the Board chooses to keep the no parking signs in place, then Ms. Donnan recommends moving forward with adopting formal restrictions. Ms. Donnan confirmed that moving violations have a different legal authority than no parking. Ms. Donnan further confirmed that there are specific requirements to carry out the criminal process. The process includes the issuance of an affidavit of facts thru the Franklin County Municipal Court. Once the Clerk processes the affidavit, the summons is then issued to the vehicle owner. Established fines must be comparable to Franklin County's schedule. The maximum fine is \$100 and it would be considered a minor misdemeanor. Chief Fisher believes the work involved seems to outweigh the parking problems within the Township. He further confirmed that without the legal process in place, no parking cannot be enforced. Mr. Earman thinks the best resolution is to remove
