Mr. Workman asked each trustee to try and answer any questions from the public and then to relay problems to the chairman.

The Clerk received the 1998 Amended Tax Rates for 1999 from the Franklin County Budget Commission. This will be the rates with the 4.0 Mill Fire Levy included. The Rates are as follows; General Fund- \$869,532.06; Police District- \$50,984.65; Fire Fund- \$6743,368.34 ; Total Mills is 17.30. #### OLD BUSINESS:

Mr. Montgomery reported that he had not been able to get together with Mr. Phillips about the pole, due to the weather but he would call him tomorrow. Mr. Workman asked that we have an answer by our next meeting in two weeks.

It was reported that our new phones and service from Ameritech would be installed sometime in the month of January. Training on the system will be given at time of installation.

The new corrected plaque for the cemetery is finished and Modlich Monuments will deliver it when they have other deliveries at Wesley Chapel Cemetery.

Captain Midgley has been on vacation, but it was reported that the rescue equipment has been ordered but it has not been received as of yet.

The status on the doors, is that Mc Knight was out last week and left and reported to Assistant Chief Long that they would do the work as soon as it warmed up. Our response was we expected the work done as soon as possible.

The Police & Firemen's Disability & Pension Fund discount for paying off the liability balance early was discussed. Our balance is \$35,897.81 and our discount for early payoff is \$11,223.36. It was moved by Mr. Rice and seconded by Mr. Junk to pay \$24,674.45 to pay off the Liability balance. On vote, Mr. Junk, "Aye", Mr. Rice, "Aye", and Mr. Workman, "Aye". Motion carried.

#### NEW BUSINESS:

Captain Ritzenhaler presented a summary of inspections from 1998, and it was noted that over 50 % of the commercial inspections were not completed due to other demands in the department, relating to paperwork, phone calls and hours of research. As our area is growing and our staff is spread thin. At this time, he requested more personnel in the Fire Prevention Bureau. It WAS moved by Mr. Junk and seconded by Mr. Rice to add another person to the bureau and continue to keep Eric Manske in the bureau until a fire fighting position becomes available. On vote, Mr. Junk, "Aye", Mr. Rice, "Aye", and Mr. Workman, "Aye". Motion carried. Interviewing for the new position will begin with Chief Mc Dowell.

Captain Ritzenhaler presented a new Fire Prevention Code for 1999. We have been using old BOCA (Building Officials & Code Administrators) codes since 1996. It was moved by Mr. Rice and seconded by Mr. Junk to adopt the new codes. Motion carried.

Chief Mc Dowell asked that 10 (ten) copies of the new code books be purchased for \$39.00 each. It was moved by Mr. Junk and seconded by Mr. Rice to purchase the books as requested. Motion CARRIED.

Mr. Rice reported that Mr. Larry Wolpert would like to organize a task force between the City of Hilliard and Norwich Township for the purpose of determining if electrical and phone service will be interrupted on and after January 1, 2000. The Y2K computer program problem may have an impact on the health, safety and general welfare of Hilliard residents. Problems after January 1, 2000 could limit the cities abilities to provide fire and emergency service to our residents. Mr. Wolpert will get with Mr. Rice after he submits this to Hilliard City Council on January 4, 1999.

A motion was made by Mr. Junk and seconded by Mr. Rice to begin proceedings on destroying outdated materials and records. On vote, Mr. Junk, "Aye", Mr. Rice, "Aye", and Mr. Workman, "Aye". Motion carried. The clerk will send a letter to the Auditors office and the Ohio Historical Society to begin the process for proper disposal of our records.

Rescue suits - The suits are in and some training has been done.

Door - No word from Mc knight on installation date.

Accrued Pension - This was paid and a savings of \$11,223.36 was realized on the early pay off.

Cemetery Plaque - This was delivered today to the cemetery.

Prevention Bureau - Chief Mc Dowell had conducted interviews and recommended that Kimberly Deaton be hired in this position. It was moved by Mr. Rice and seconded by Mr. Junk to hire Mrs. Deaton. On vote, Mr. Rice, "Aye" Mr. Junk, "Aye" and Mr. Workman, "Aye". Motion carried by majority. She will begin on February 1st, 1999. It was also noted at this time, that Eric Manske had withdrawn his request to be considered for any fire fighting positions coming up in the future.

Y2K Task Force - Larry Wolpert will get back to us within 30 days on the status of this task force, and where we will go from here on.

Record Disposal - The Clerk is working on the procedure now.

Timberbrook Meeting - All of our trustees attended this meeting and the association members were very happy with Norwich Township and all they have done for them. They were pleased with the fire department and also the snow removal work that was done the last 2 weeks. It was mentioned that they would have to trim trees that are located on cul de sacs as our trucks cannot plow because the trees are in the way of our trucks. When we make our road survey with the County, we will ask their advice as to what to with this problem of the trees.

#### NEW BUSINESS:

Our promotion list for Lieutenant expires on July 10, 1999 and the cost of the exams will be \$700.00 plus \$10.00 per person taking the exam. We currently have 23 people eligible, for a cost of \$930.00. It was moved by Mr. Junk and seconded by Mr. Rice to proceed with the promotion test. Motion carried by majority.

ACLS Recertification - This is scheduled for February 20, 1999 and the total cost will be \$468.00. This will cover, cards and administrative costs, texts, and instructors. It was moved by Mr. Junk and seconded by Mr. Rice to update the ACLS Recertification. On vote, Mr. Junk, "Aye", Mr. Rice, "Aye", and Mr. Workman, "Aye". Motion carried.

E.M.T. Recertification - We have 6 people that need to recertify their fire EMT instructors cards. The classes are held February 26-28, 1999. The members are Dave Long, Bill Midgley, Vince Papa, Bob Kaufman, Reggie Brown and Greg Collier. It was moved by Mr. Junk and seconded by Mr. Rice to recertify all at a cost of \$167.00. Motion carried by a majority vote.

Road Survey - This is usually done in January, but due to our snow and ice problems with the roads, it has not been done. Mr. Montgomery will check with the County to see when they will be starting on this project.





Road Closure - June 3-4, closure of Davidson Road at intersection of Dublin.



### OLD BUSINESS:

Officer Moreland presented a report that covered the dates of 5/23/99 to 6/3/99. 14 incidents were listed. Our new permanent first shift Officer is Jeff Reed and our second shift Officer is Mike Pennington.

Knox Box - A resident, Jeffrey Gergal of 5038 Mengel Lane, Hilliard, Ohio was present at our meeting to express his concerns about Knox Boxes. He does not like the mandatory requirement to have a Knox Box at his home when his alarm system is hooked into the fire station. He stated that Norwich Township is the only township requiring the box. Mr. Gergal wants a choice in this matter. He stated that many older residents were taking off the fire protection from their security systems. Annexation from Washington Township to Norwich will be presented to Hilliard City Council on August 2, 1999. Mr. Junk will attend the council meeting and report back to us.



MORPC - September 15, 1999 will have a meeting about the Sugar Development and Mr. Junk will attend.

Investment Companies - The Trustees and the Clerk had previously listened to two investment companies, United American Capital Corporation and 5/3 Liquid Asset Management division. The meeting was called to order by Mr. Workman, Chairman. A prayer was offered by Mr. JUNK and the pledge of allegiance was repeated by all. The minutes were accepted as presented.. Bills in the amount of \$186,560.64 were presented for approval. A motion was made by Mr. Rice and seconded by Mr. Junk to approve the bills. #### OLD BUSINESS:

Officer Banche was present and presented us with a detailed report running from 9/12/99 to 9/25/99. Dispatched runs, 30; pick up runs, 130; domestic runs, 0; total on duty hours, 80. 5 accidents investigated; 3 non accident citations; 15 traffic warnings; 1 misdemeanor arrest. 2 prisoner conveyed; 1048 miles driven; reports taken, 5; records checks, 16; business checks, 13; vehicles impounded, 2; motorists assists, 5; felony arrests, 1; gun runs, 3; F.I. cards, 10; township meetings attended, 2.

Sugar Development: Concerned residents from Norwich Township and Brown Township attended our meeting this Monday night. In attendance were; Glen Anderson, Mr. & Mrs. Vic Palmer, Mr. & Mrs. John Wilt, and Mr. & Mrs. Frank Shirley. They are very opposed to this development and the disposal plant the developers are proposing. The area for the development has very poor drainage in Norwich Township. They are concerned about the smell from the waste plant. The developers want the homes to be built in Norwich Township, rather than Columbus. It will be easier to sell homes in Hilliard because of the schools. The residents in attendance had talked to other townships where these disposal plants have been tried, and they do not work well. They are not always successful as to keeping the smell down and also the disposal of waste does not always work the way it is supposed to. The residents were asking the Trustees of Norwich Township to oppose this development. Our Trustees told the residents that there has been alot of negative response to the development, and even though the township does not want to loose the area and tax base to Columbus, they are looking out for the good of the community and will not support the development.

Annexation of Wilcox Road - On the vote at the last Hilliard City Council meeting it was 100% in favor of annexation to Norwich Township. The paper work will be filed in 30 days.

4 Way Stop - The Franklin County Engineers will run a traffic survey to determine if a stop sign is needed at this area in Ridgewood near the school. Our Maintenance crew has also trimmed bushes in this area to help with visibility.



Held

Flag Pole - Chief Mc Dowell had received a bid to do the work from Bryan Lee Masonry. The base around the pole will be 4' square. Both plaques will also be installed. Mr. Lee will charge \$550.00 to do the labor and we will provide all the materials. Mr. Rice moved that we contract with Bryan Lee Masonry to do the work for \$550.00. Mr. Workman seconded the motion. On vote, Mr. Rice, "Aye", Mr. Workman "Aye", and Mr. Junk, "Abstain". Motion carried. We will get exact material needs from Mr. Lee and proceed with the job as soon as possible.

Enclosure of Engine 80 - The company is possibly coming next week to do the work and at that time will give us an estimate for enclosing the ladder.

Easements - Mr. Montgomery received word from the county that we have a 50' easement on Thoburn Drive. This easement gives us the right to take down the dead tree on this Road. He is getting estimates from two (2) tree companies on the cost to remove the tree. This tree is too large for us to do ourselves. Napier Tree Service and Jude & Mc Coy have been contacted.

Investments - United American Capital Corporation (UACC) has written up a new investment policy for us to send to the State Auditors Office. It was moved by Mr. Junk and seconded by Mr. Rice to accept this new investment policy and forward it on to the Auditors Department. On vote, all "Aye". We have also signed a contract with UACC for \$750.00 a month for two years as our investment advisors.

Cable Companies - Residents from Timberbrook have called us very concerned about the cable companies in their area doing surveys. They were told that the companies have a right to do this so long as they do not tear up residents properties.

#### NEW BUSINESS:

Heart Monitors - Assistant Chief Long advised us that we have been given a chance to upgrade our heart monitors with the latest equipment currently on the market. These units can also be updated as new technology comes along. Physio Control is offering us "Demo" units at a reduced price. These units come with a complete new factory warranty. We currently have State EMS grant money available to offset some of the cost for up to two (2) units. The cost of new units would be \$26,180.00 and the Demo units would cost \$19,228.00. Existing units would be moved onto engine companies that are being used as first responders, or allow for a future third medic to be placed in service when needed. In addition a new battery support system for our Lifepak battery is needed. The existing one will be moved to Station 82. this system is used to charge and analyze the batteries for our Lifepak monitors. The cost of this new system is \$17,000.00. It was moved by Mr. Rice and seconded by Mr. Junk to purchase the Demo units and also the new system for Station 82. Motion carried by majority.

High Band Radio Equipment - Assistant Chief Long told us of the need to upgrade our ability to communicate on the high band radio systems. Upgrading our system will give us a secondary communication system should the 800 radio system fail. Our current low band system is becoming obsolete as these radios are several years old. Firefighter Skeldon has helped to come up with the following list of radios needed: Mobile radios (8) at a cost of \$4392.00; Walkies (2) at a cost of \$1792.00; and additional walkies (6) at a cost of \$6,142.00. This is a total expenditure of \$10,504.00. These prices are quoted on new radios. Firefighter Skeldon has a source to buy good used radios at a fraction of the above price. The cost of the seminar is \$80.00 and the cost of a room will be in the range of \$50-65. It was moved by Mr. Rice and seconded by Mr. Workman to send Lt. Brown to this seminar. Motion carried by majority.

Hazardous Materials Training - The grant was approved for the training of our personnel. Our request of \$10,098.00 was approved and is a reimbursement grant.

Photo Board - Captain Ritzenthaler and Inspector Manske have been working on updating our photo board in the front office. The cost of framing and matting is \$310.00. It was suggested that we also put a duplicate out at Station 82, since we are manning that location. It was moved and seconded that we complete two (2) photo boards at a cost of \$620.00. 





Homestead Park - Residents from all over the area use the Homestead Park in Washington Township, and none use it as much as the residents from Norwich Township. Washington Township is starting to plan on expansion of the facilities at the park. Norwich Township is very much interested in helping in the expansion of the park. One area that we are interested in funding is a handicapped assessable play area at the Homestead. ### REGULAR MEETING OF THE NORWICH TOWNSHIP TRUSTEES

DECEMBER 6, 1999

The meeting was called to order by Mr. Workman, Chairman. A prayer was offered by Mr. Rice and the pledge of allegiance was repeated by all. The minutes were accepted as presented. Bills in the amount of \$134,764.90 were presented for approval. A motion was made to approve the bills. Motion carried.

A copy of the warrants for this pay period will follow these minutes.

#### OLD BUSINESS:

Sheriff Report : Dispatched runs, 27; pick up runs, 145; on duty hours, 80; total accidents investigated, 4; accident citations, 1; non accident citations, 6; traffic warnings, 17; warrant arrests misdemeanor, 1; prisoners conveyed, 1; OMVI arrests, 0; total miles driven, 1097; reports taken, 5; F.I. cards, 0; record checks, 20; house checks, 22; business checks, 29; motorist assists, 1; vehicles impounded, 1.

4 Way Stop - The Township received a letter from Michael Meeks, Traffic Engineer for Franklin County Engineers Department regarding the survey for a 4 way stop at Schritzing Road and Stellar Drive. The installation of 4 way stops is governed by State Law and State traffic standards, which are in conformance with the Federal Manual on Uniform Traffic Control Devices. These standards require certain criteria before a four way stop can be justified. There are four reasons, technically referred to as warrants, any one of which could establish a need for a 4 way stop. Parameters that are included are speed, traffic volumes, sight distance and traffic accidents. Traffic counts were conducted on 11/9/99 and 11/10/99 between the hours of 6 am and 7 pm.

The study indicated that Schirtinzer and Stellar Drive met NONE of these warrants at this time. The Trustees of Norwich Township in turn, sent a letter to John Circle regarding this survey. After talking with many of the families in the area we feel they are justified in their request to protect their children. We are hoping they, the County, will reconsider this matter. Our officers on duty in this area are going to conduct their own survey for a few days and report back to us with their results.

Chairs - 4 chairs purchased from Sam's Club are in use at Wesley Chapel Cemetery, and 9 chairs were taken out to Station 82 for use in the bunk room and other areas.

Greenways Committee - The meeting was canceled.

Berms - The berms at the cemetery are still being filled in and readied for planting next spring. The cave area has been cleaned out for this year also.

Cobb Rental Annexation - January 5, 2000 is the date for this annexation to Columbus. Mr. Junk and Mr. Workman will survey the surrounding neighbors and see if they are aware of what is going to happen in their neighborhood on this date.

Treadmill - The treadmill for Station 82 was delivered, but it was the wrong model. The new model is to be delivered and set up as soon as it comes in.

Road Survey - We have not been given a date for this yet. The county was hoping to do this before the end of the year. Mr. Montgomery will keep us posted.

New Engine - They are starting to build the pump module now.

#### NEW BUSINESS:

Land Use Committee - In January we will begin to work on this with the help of Alan Neimeyer.

Capital Improvements Budget - Chief Mc Dowell advised us that the City of Hilliard does not have the roads for the Soma Development in the budget until the year 2003. This puts our station for the eastern part of Hilliard at least 4 years away. He feels we should look into this, as it may be too long to wait on construction of the next station.

Station 82 - We are looking to begin manning this station on Wednesday, December 8. Four men, one lieutenant and 3 firefighters, will staff Station 82.

Snow Plows - Our snow plows are ready for winter and we have a supply of salt already on hand, if needed.

Foundations - Mr. Montgomery advised that all foundations have been poured for this year. Any new orders for foundations that come in, will be poured in the spring.

Furnace - The oil furnace at the Cemetery has been fixed and is running properly.

Northwest Franklin County Historical Society - Two members of the Society, Pat Garbrant and Tim Woodruff were present at our meeting to tell us about the proposed Town Hall the Society is planning on building. The Society is a non-profit organization whose buildings are located at the Franklin County Fairgrounds. The cost of the new structure is \$450,000.00. They asked that Norwich Township give a donation to the construction of the Town Hall. Mr. Workman told them that we would have to check with our Prosecuting Attorney to see if the Township is allowed to make a donation to the Society. We will get back to the Society when we get an answer.

Stewards of Darby - Representatives from this group visited our meeting to let us know of their opposition to the Little Darby National Wildlife Refuge. The homeowners and landowners in this area of Madison, Champaign Union and Clark County are seeking our support in Opposing the LDNWR for the following reasons:

1. The blatant infringement on Private Property Rights
2. The loss of Local Government taxing structure
3. The negative impact on public school funding
4. The loss of livelihood for many family farms
5. The hindering of the American farmer from meeting the world food demand
6. The increased public health risk caused by the enlargement of an environment that is conducive to the multiplying of the mosquito population, thus possibly spreading more deadly diseases
7. The increased damage of cropland on undesignated land use due to the increased migrating wildlife
8. The discontinuing of drainage tile that will cause much undesignated acreage to be unable to drain, thus unable to farm.
9. The real threat to 200+ family farms uprooted
10. Total disruption of four villages
11. The detrimental effect on the eight adjoining cities
12. The unnecessary acquisition of farmland for use as a tallgrass prairie/wetland wildlife refuge by a Fish & Wildlife Service that cannot financially maintain its currently owned property.
