These have been low flying planes and again I believe one plane that has made numerous passes over the property belongs to a flight school operating out of Norwood Memorial Airport. Again, the flight schools should not be allowed to use the air space over Hilltop Gardens and the surrounding neighborhood as their practice parking lot for their students.

Again, the residents of Hilltop Gardens Condominium complex and the surrounding neighborhood request relief from the constant and pervasive noise being inflicted upon us.
