Would you please let me know at your earliest convenience what I need to do to file a formal complaint and steps to take to alleviate the constant and pervasive noise being inflicted on myself as well as the other residents of my community stemming from the flights taking off at Norwood Memorial Airport and the flight schools using the airspace over Hilltop Gardens Condominium Complex as their practice parking lot.
