Mr. Raymond: We are disappointed to file this complaint as we thought there had been some efforts to reduce the overflights over the Winfield/Rock Streets neighborhood. This did not happen on Sunday March 5, and I received several complaints about the 90 airplanes that flew over our neighborhood, a clear day with no wind. Other than the single 7:30am plane, the overflights started at 8:20am and continued all day until about 5pm, and these overflights included some low, loud jets. From noon until 1pm there were @15 flights. From 1pm until 2pm there were @25 flights. Having a few of those 90 flights redirected over Coolidge Avenue, an adjacent street, is not much of a redirection if we can still see/hear how low and loud those flights are. From mid-May 2022 until Sunday March 5, we're now seeing/hearing (and breathing the air from) @6600 overflights, a lot of flights over a congested residential neighborhood. We're looking forward to the subcommittee meeting and the March Norwood Airport Commission meeting to resume and continue the redirection of these overflights.
