## FAA Federal Register Notice: Request for Comments on the Noise Policy Review

Dear Valued Community Members,

**On Monday, May 1, 2023, the Federal Aviation Administration (FAA) will publish in the Federal Register a Request for Comments (Request for Comments) seeking public input on four key considerations of its Civil Aviation Noise Policy. The FAA is asking the public for input regarding how the FAA analyzes, explains, and presents publicly changes in aircraft noise exposure to affected communities. The posting of the Request for Comments will start a 90-day comment period during which the public can share their input by submitting a written comment to Docket FAA-2023-0855 at [www.regulations.gov](http://www.regulations.gov). The comment window will close on Monday, July 31, 2023.**

The Request for Comment builds on and responds to public feedback on the FAA's [January 13, 2021 Federal Register Notice](#). That Notice provided an overview of the FAA's noise research portfolio and sought input to assist the FAA in assessing how resources should be directed to better understand and manage the factors underlying concerns from aircraft noise exposure. The resounding theme of comments filed in response to that Notice requested that FAA begin the process of updating its noise policies, rather than wait for the outcome of ongoing research efforts.

We are committed to providing ample and meaningful public engagement opportunities during the public comment period. We have scheduled a series of four webinars between May 16 - 28 to provide stakeholders an opportunity to engage with us on this topic.

We have launched a project website at <http://www.faa.gov/noisepolicyreview>, which will provide updates, resources, and access to webinar recordings. We will also soon launch a Spanish language website to expand our outreach efforts. We look forward to your participation and engagement with the Notice.

Please help us get the word out and further disseminate this notification as you deem appropriate.

If you have any questions or need information in the meantime, please let us know. Thank you for your partnership in addressing aircraft noise concerns.
