Required Planning Documents

Construction



Year 1-4

Transportation Improvement Program (TIP)

- Comprised of projects in the first four years of the TYP.
- Encompasses all federally funded projects in the region.
- Fiscally constrained in accordance with known revenues.
- Updated every two years at the conclusion of the TYP process.

Federal Requirement

Year 5-10

Ten-Year Transportation Improvement Plan (TYP)

- State-level funding commitment for listed projects.
- Encompasses all surface and air transportation projects in NH.
- Fiscally constrained against known and anticipated revenues.
- Regions are provided funding allocations for new projects.

State Requirement

Year 11-20+

Metropolitan Transportation Plan (MTP)

- Identifies long-term project needs to meet regional goals.
- Inclusion in the MTP does not constitute a funding commitment.
- Fiscally constrained against known and anticipated revenues.
- Projects in the MTP form the "pipeline of projects" for the TYP.

Federal Requirement

Concept

FY 2023-2026 NRPC TIP

TIP Development Process

- Begins when a new State Ten Year Plan (TYP) is adopted.
- 7/2022 - Governor signed the 2023-2032 TYP.
- 7/2022 – 11/2022 - NHDOT assembled STIP from the first 4 years of the TYP.
- 11/2022 - Initial project list was released to MPO's, RPC's, & other planning partners.
- 12/2022 - Interagency consultation & review.
- NHDOT incorporates comments & releases draft STIP along with fiscal constraint documentation.

FY 2023-2026 NRPC TIP

TIP Development Process

- 12/2022 - 1/2023 – NRPC assembles TIP & prepare for approval process.
 - MTP project list & financial plan were also updated to maintain consistency with the TIP.
- 1/13/2023 - 30-day public comment period began.
- 2/8/2023 - TTAC meeting to recommend adoption by NRPC MPO.
- 2/14/2023 – Public comment period ends
- 2/15/2023 – NRPC MPO public hearing to consider adoption of the TIP and minor MTP update.

FY 2023-2026 TIP New Projects

- **Amherst (40657)**
 - Bridge Replacement – Thornton Ferry Rd. over Beaver Brook
- **Merrimack (29174)**
 - Bridge Replacement – US3 over Beaver Brook
- **Pelham (29450)**
 - Bridge Rehabilitation – Old Bridge Street over Beaver Brook
- **Wilton (15768)**
 - Bridge Rehabilitation – Old County Farm Road over Blood Brook

These local bridge projects have been added to the TIP because State Aid Bridge Funding previously programmed for Construction phase has been swapped with Federal (MOBIL, BRGBIL) to accelerate their schedules.

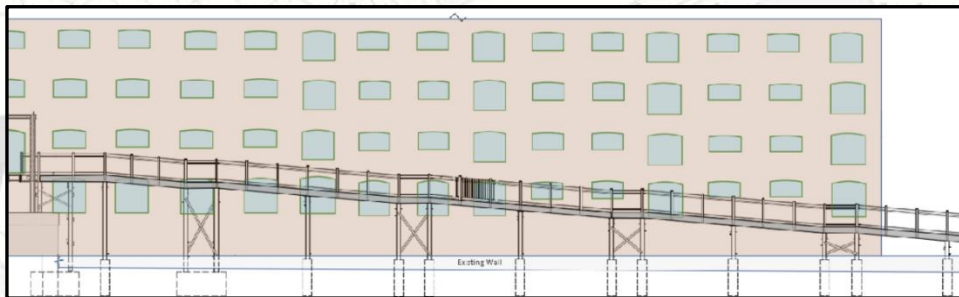

➤ Bedford-Merrimack (16100) – F. E. Everett Turnpike

- Project Scope – Improvement to Bedford Mainline Toll Plaza to Institute Open Road or All Electronic Tolling
- Total Funding in TIP - \$11,250,021
- Total Project Cost – 13,455,021
- Construction Schedule – FY2023-24

- ❖ The All-Electronic Tolling option has been selected for implementation (versus Open Road Tolling option)
