# Nashua Region Metropolitan Transportation Plan



This document provides a basic blueprint for long-term transportation investment in the Nashua Region to the horizon year 2045. The plan is structured around four major goals, developed through public outreach and coordination with advisory committees, which include Mobility and Accessibility, Quality of Life, System Sustainability and Implementation.

This Minor Update revises the project list and associated fiscal constraint analysis for highway and transit projects and programs.

#### **FINANCIAL ANALYSIS**

#### **Highway Fiscal Constraint Analysis**

Federal regulations require that the MTP "shall include a financial plan that demonstrates how the adopted transportation plan can be implemented." Requirements include: estimates of costs and revenue sources "that are reasonably expected to be available to adequately operate and maintain Federal-aid highways and public transportation; estimates of available funds from all necessary financial resources; recommendations for additional strategies to support the availability of any new sources; all projects and strategies proposed for funding under title 23 U.S.C, title 49 U.S.C. Chapter 53 or with other Federal funds; State assistance; local sources and private participation; use of "year of expenditure dollars" for estimating revenue and costs in future years; specific financial strategies required to ensure the implementation of Transportation Control Measures in air quality nonattainment and maintenance areas, and "for illustrative purposes, the financial plan may – but is not required to – include additional projects that would be included in the adopted transportation plan if additional resources beyond those identified in the financial plan were to become available."

For the ten-year period including FY2023 - FY2032, the FHWA statewide programmed amounts are utilized for the fiscal constraint analysis. For the period including FY2033 – FY 2045, the average of the FY2023 – FY2032 is used. This is a conservative assumption, as it would be expected there would be some level of increase in federal funds over the long term.

Each region receives a "theoretical allocation" of the statewide FHWA resources that is based on the percentage of statewide population in the region and the percentage of federal aid road miles. There is a 50/50 weight applied to each. The NRPC region contains 15.8% of the state's population and 9.0% of the federal aid road mileage. This results in an allocation of 12.35% of federal funds to the NRPC region.

The allocation amount does not represent the amount that is available for new local or regional projects. A substantial portion of the region's theoretical share goes toward statewide or programmatic projects, which include highway paving/reconstruction, bridge rehab and reconstruction, safety improvements, signage, etc. The regional share of the statewide total is subtracted from the theoretical allocation to provide a balance remaining for new local and regional projects.

The fiscal constraint table produced for this MTP indicates that the cost MPO projects and the MPO share of statewide projects is less than the theoretical allocation for the 2023-2026 TIP period by \$19.4 million. For the MTP time frame through 2045 a balance of \$182.1 million is projected, which will fund future regional TYP project submissions through 2045.

Beyond 2022, the final year of the TIP, statewide project costs are inflated by 2.8% annually. NRPC MPO projects have already been inflated in the project estimates.

A table is also provided to estimate non-federal revenue sources for projects, including state and local funding. This table is not directly related to the federal fiscal constraint; however, a portion of these funds will be applied as local match. Toll credits, which are a non-cash match to leverage federal funds, are also shown for the 2023-2032 Ten Year Plan period per state programming and estimated for the remainder of the MTP time frame.

#### **Highway Operations and Maintenance Resources and Needs**

Regulations included in 23 CFR Part 450.218(m) state that "For purposes of transportation operations and maintenance, the STIP shall include financial information containing system-level estimates of costs and revenue sources that are reasonably expected to be available to adequately operate and maintain Federal-aid highways [...]." The following provides estimates of maintenance and operations needs for the Federal-aid highway system in the NRPC region and statewide for the period 2023 to 2026. The estimates are based on NHDOT figures from the FY 2023 – FY 2026 STIP Financial Constraint Summary, the FY2023-2032 Ten Year Plan, and an analysis of Federal-aid eligible roadways in the SNHPC region.

#### **Transit Operations & Maintenance/Fiscal Constraint Analysis**

For the highway financial analysis, development of fiscal constraint of federal-aid roadways and calculations of operations and maintenance needs were independent analyses. This is because fiscal

constraint is a process to ensure that federal resources are adequate for all regional projects and programs, while O&M determines the amount of all resources (federal, state, local) that will be needed to conduct the maintenance requirements of the federal-aid roadway system.

The determination of transit fiscal constraint, conversely, is a process that first calculates O&M needs of the public transportation system, in order to identify the level of FTA operating assistance that will be required for each year. This amount is then carried over from the O&M Needs table to the fiscal constraint table, where the annual level of operating assistance is subtracted from the total FTA apportionment (FTA 5307, 5310, 5339) to determine the annual amounts available for capital expenditures. From the transit systems Transit Asset Management Plan, a long-range schedule of capital needs is plugged into the Metropolitan Transportation Plan fiscal constraint table. Where shortages of funding for capital projects is determined on a yearly basis, target dates and amounts for FTA 5339 discretionary grants are determined.
