What is the Locally Coordinated Transportation Plan (LCTP)?

The Locally Coordinated Transportation Plan is a document that:

- Assist stakeholders to help residents meet their transportation need
 - Provide strategies for meeting local needs
 - Prioritize project implementation and funding

It is also a required document for Federal funding and needs to be updated every for 5 years!

Legal Obligations

FTA Section 5310 - Enhanced Mobility for Seniors and Individuals with Disabilities Program & Requirements:

- Federal law requires projects selected for funding under this program be included in a "locally developed, coordinated public transit human services transportation plan"
- Requires participation by seniors, individuals with disabilities and the general public; and
- Representatives of public, private, and nonprofit transportation and human services providers



Nashua Transit System Comprehensive Plan

The Locally Coordinated Transportation Plan update will run concurrently with an update to the Nashua Transit System Comprehensive Plan.





Timeline

- Miliyara
- 1. Regional & Town Profiles/Demographic Analysis (now – March)
- 2. Inventory existing services and communities (March 2024)
- 3. Conduct public outreach (now- July 2024)
- 4. Identify community needs/tabulate survey results (June/July 2024)
- 5. Generate strategies and prioritized projects for funding (July-September 2024)

ne Falls

- 6. Draft LCTP (October December 2024)
 - 7. Finalize LCTP (January February 2025)
