

# Oak Park Saves \$1.2 Million By Refinancing 2006 Street Improvement Bonds

The City of Oak Park refinanced their 2006 Street Improvement Bonds from a 4.5% interest rate to a 2.52% interest rate to save nearly \$1.2 million, net. For the average taxpayer owning property in the City of Oak Park, that equates to an annual savings of approximately \$50 to \$75 per taxpayer.

"We were able to refinance the City's 2006 Street Improvement Bonds in a manner in which we pass along savings directly to our taxpayers through a decrease in their property taxes," said City Manager Erik Tungate who credits a lower interest rate, a window of opportunity to refinance, and the remaining length of time in the amortization schedue as the contributing factors. "We are always in pursuit of opportunities to save our residents money, either directly or through city operations, and this is the result of our most recent efforts."

In 2013, Oak Park refinanced its 2003 Street Improvement Bonds from a 4.5% to a 1.9% interest rate on the remaining 15-year amortization to save approximately \$1.8 million.

"It is always a proud moment when the City can explain a tax reduction, versus a tax increase," said Oak Park Mayor Marian McClellan. "We accomplish this by being responsive to the needs of our residents and our business community while promoting a strong culture of excellence."



## Standard and Poor's Upgrades City Rating to A+ Positive

Standard & Poor's revised the City's rating to A+ positive from A+ stable. "Our policies have led to improved financial performance over the last three years. This is full recognition that our hard work is starting to pay off and the City is on a path to prosperity," said Erik Tungate, Oak Park City Manager. 

The matter was properly investigated, the employee was immediately terminated, and the appropriate people are charged with the crime. The City has subsequently been reimbursed 100% by an insurance policy the City held.

Make no mistake, when issues as serious as this surface, we will use every resource available to find them and we will root them out on your behalf. We take your funds — your hard-earned taxpayer dollars — very, very seriously. We put safeguards in place to guard against this ever happening again.

The City's finances are stronger than they have been in years. Standard and Poor's has upgraded our rating to a A+ Positive, we are carrying a 15% leveraged general fund balance of \$2 million per year, and we saved taxpayers \$1.2 million by refinancing our 2006 Street Improvement Bonds.



# **ELECTIONS**: Oak Park Residents Vote for Mayor, Two Council Seats and Ferndale School Millage

### Choose One of Two Ways to Vote

#### **VOTING OPTION NO. 1: Absentee Voter Ballot**

**STEP 1: QUALIFY.** Absentee voter ballots provide voters with a convenient way of voting when they are unable to attend the polls on Election Day. A voter may obtain an Absentee Voter Ballot if he or she is age 60-years-old or older, unable to vote without assistance at the polls, expecting to be out of town on election day, or unable to attend the polls due to religious reasons. **STEP 2: APPLY.** Request an Application for Absentee Voter Ballot by calling (248) 691-7544, go online at www.michigan.gov/vote, or inquire at the City Clerk's office. Ballots will be mailed within one business day after receipt of application.

**STEP 3: VOTE.** Vote, then seal the ballot in the return envelope provided, and sign the envelope in the red box labeled "SIGN HERE." **STEP 4: RETURN BALLOT**. The Absentee Voter Ballot must be returned to the City Clerk's office no later than 8 p.m. on Election Day. The Clerk's office will be open on Saturday, October 31st, from 9 a.m. to 2 p.m. Voters may come to the City Clerk's office on Monday, November 2 until 4 p.m. to obtain an Absentee Voter Ballot which must be voted at the Clerk's Office.

#### **VOTING OPTION NO. 2: Vote in Person**

The City of Oak Park is divided into 16 precincts. Voters are assigned a precinct in which to vote based on where they live. Polls are open on Tuesday, November 3, 2015 from 7:00 a.m. until 8:00 p.m. All voters will be asked to provide photo identification as required by law.

# CURBSIDE LEAF REMOVAL: Here's the Scoop!

#### The City of Oak Park has two options for residential leaf collection:

#### **OPTION NO. 1: Dispose of leaves along with regularly scheduled** weekly refuse collection

Leaves must be placed in a paper compost bag no heavier than 30-gallons or in a trash can no larger than 35-gallons that is marked with a yard waste decal. Decals can be obtained from the Water Department or the Public Works Department. Containers with leaves must be separated from trash and recyclables. Please note, leaves placed in plastic bags will not be picked up.

#### OPTION NO. 2: Rake leaves into the street according to the 2015 Curbside Leaf Removal Schedule

From October 19 to December 18, leaves must be raked into the street for curbside collection on the dates that are appropriated to your section number. (See map for details). Large vacuum trucks and loaders remove the leaves from the street. Sweeper trucks sweep the streets in each section after final leaf pick-up. To ensure collection, residents must rake leaves out to the curb prior to the first collection date assigned for that week and their section. For example, if a resident lives in Section 2, and their second scheduled pickup days are October 28 and 29, leaves should be raked to the street prior to October 28th. After the final pickup date for your section, leaves can be bagged and placed to the curb for pickup on the regularly scheduled trash day.

Voters in Precincts 14, 15 and 16 who reside in the Ferndale Public School District will have the opportunity to vote on a millage proposal for the District.


# **YOUR VOTE COUNTS**

Vote on Tuesday, November 3 between 7 a.m. to 8 p.m.

#### **HELPFUL TIPS:**

- Rake leaves to the gutter line, at least four inches from the curb to help to ensure that street drains do not become blocked.
- Rake leaves to the curb a day or so prior to the scheduled date of the designated section to ensure leaves are picked up.
- Leaves that are mixed with debris, brush, or grass clippings will not be removed.
- Last day for bagged leaves and yard waste collection is December 18.
- Do not park on or near leaf piles on the scheduled collection days.
