# 2017 SUMMER PROPERTY TAX BILL

1 **MILL** = \$1 OF **PROPERTY TAX** PER  
\$1,000 OF **TAXABLE VALUE**

**(Taxable Value X Millage) / 1,000**  
= **Property Tax**

- CITY OPERATING:**  
**(\$30,000 X 17.2382) / 1,000**  
= **\$517.14**

**ADMIN FEE = 1% of total property tax**

**TOTAL DUE = \$1,820.14**
