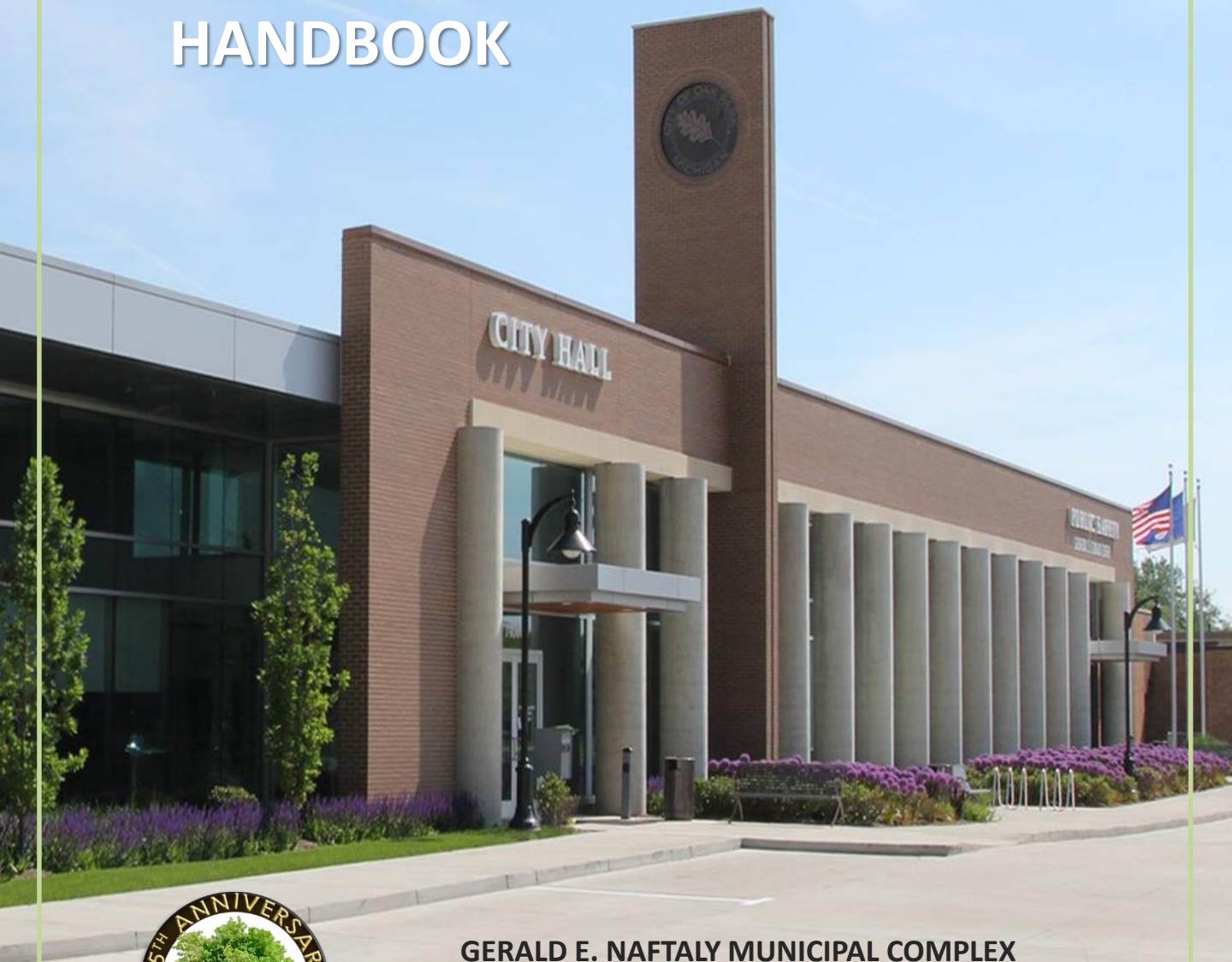

# Map of the City of Oak Park

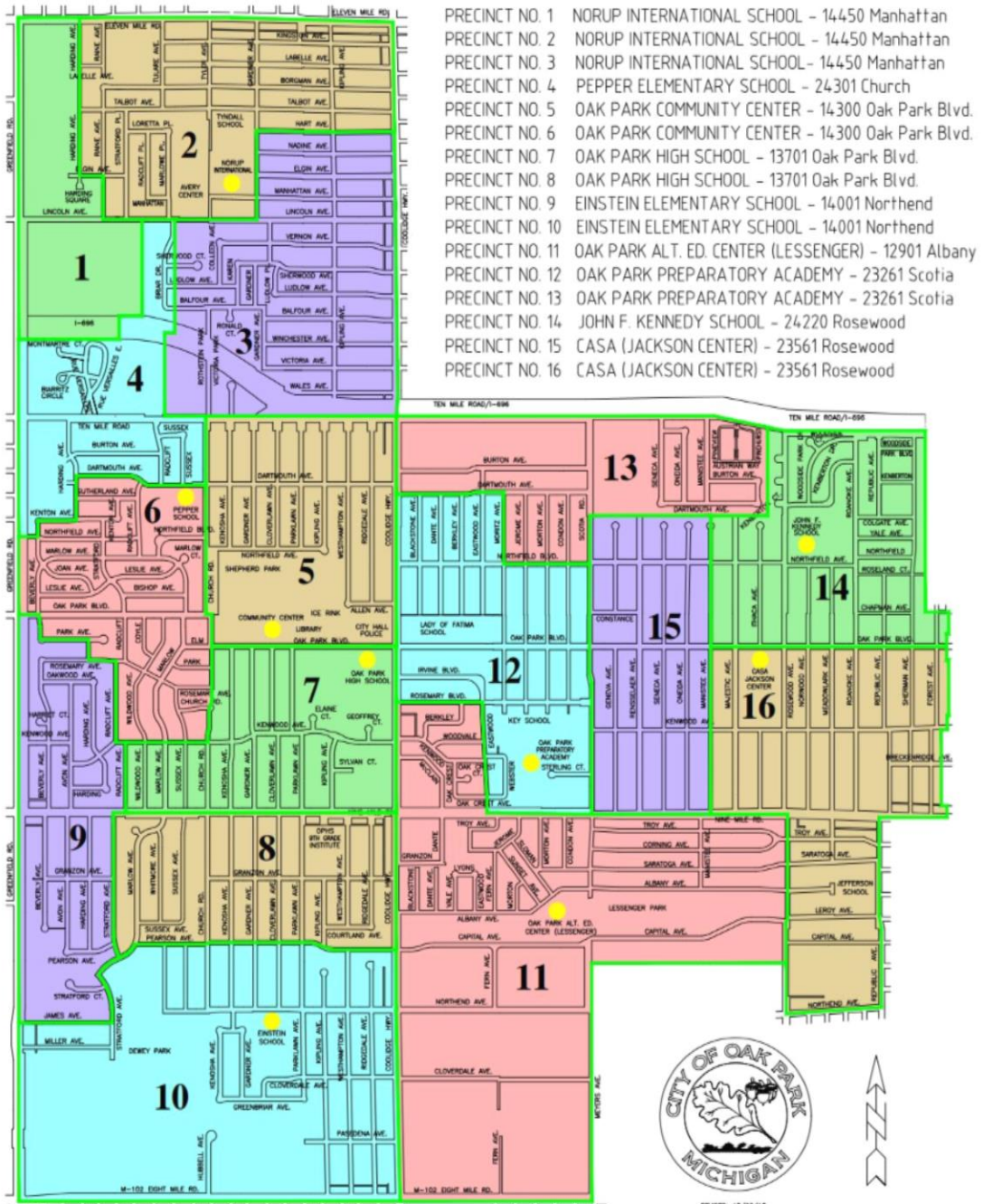
## THIS MAP

## **Government in Action**

The City Council convenes every first and third Monday of the month beginning at 7 p.m. When a meeting day falls on a holiday, the Council meeting will be postponed until the following business day. Council occasionally holds study sessions prior to the regular meeting in order to review issues in-depth. With a few exceptions as allowed by law, all Council meetings are open to the public. All meeting dates and times are posted at least 72 hours in advance on the City's website and in the lobby of City Hall.

## SNOW EMERGENCIES

- By ordinance, snow emergencies are called by the Director of Public Works when more than four inches of snow falls or other hazardous conditions develop.
- During snow emergencies, parking on public streets is not permitted until City crews have sufficiently plowed.
- Designated emergency parking areas are available.
- City of Oak Park snow emergencies are announced through the City's website, Facebook, Twitter, Comcast OPTV 16, and Community eBlasts (email).
- For City building closures due to weather, also check your local television and radio stations.

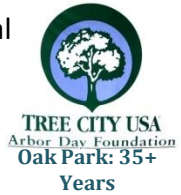
## TREES AND POWER LINES

## DEPARTMENT OF PUBLIC WORKS (DPW)

The Department of Public Works, or DPW, provides City services divided among five divisions: Streets, Water and Sewer System, Parks and Forestry, Motor Pool, and Facilities Maintenance. The department's overarching goal is to provide a high quality of life to residents, local businesses and fellow employees by delivering responsive, efficient and effective services.



## ANNUAL BEAUTIFICATION AWARDS

The City of Oak Park's Beautification Commission promotes an annual home improvement campaign in which the commission recognizes homes and businesses in Oak Park for outstanding yards and gardens.

## TRASH COLLECTION

### Regular Collection

- All rubbish must be curbside by 7 a.m. on collection day.
- Place trash curbside at or after noon the day before collection day.
- Bags or trash cans only (no boxes). You must not exceed 32 gallons each. Trash must be easy to handle.
- About seven bags/cans or bundles (or one cubic yard) allowed per collection.
- Regulation-size, 95-gallon, mini-dumpsters are allowed and can be ordered through the City's Water Department.
- Up to three large household items per pick-up are allowed, but must be separated from trash.
- See the City newsletter/website or call DPW for holiday pick-up schedule.
- Items NOT permitted, include automotive parts, tires, waste oil, drums, pallets, gravel, slate, tile, stone, poisons, dead animals, ammunition, explosives, concrete, soil, medicine, drugs, construction or move-out debris, or any item that may harm collection personnel.
- Unused, prescription medications can be disposed of at the Department of Public Safety building located at 13800 Oak Park Blvd, Oak Park, MI. Call (248) 691-7520 for more info
- See below for criteria on yard waste, branch and hazardous waste pick-up.



### Yard Waste

- Yard Waste and brush are collected weekly at curbside from mid-April through early December.
- Yard waste must be in brown paper bags or 32-gallon garbage cans marked "Yard Waste."
- "Yard Waste" stickers can be obtained in the Water Dept. in City Hall or at DPW.
- Bags or cans must not exceed 60 pounds.
- Before mid-April, drop yard waste at SOCCRA Center located at 995 Coolidge Rd. in Troy. For more information, visit <http://socrra.org/>.

### Tree Branch Collection

- Only brush resulting from yard maintenance (organic) is collected.
- Small brush (4" max; 1/4" diameter or less) must be tied in bundles less than 60 pounds.
- Large brush (8" max; 6" diameter or less) must be stacked on curb with cut-ends together for the chipper
- Items not permitted: material produced by commercial landscapers or tree trimmers, total tree removal, logs, stumps or roots. (Use a private contractor in these instances.)

### Recyclables

- Recyclables must be placed in approved containers
- Permitted items include, newspaper, tin, aluminum, glass, plastic containers, and household batteries.
- For a complete list of allowances, contact DPW.
- Recycling bins can be purchased at the Water Dept.

### Hazardous Household Waste

- At no charge, residents may drop off items, such as paints, garden chemicals, household cleaners, and solvents at the MRF Drop-Off Center at 995 Coolidge Rd. in Troy.
- Residents must first call for an appointment at (248) 288-5153.

## TECHNICAL AND PLANNING (T&P)

**Technical and Planning Services (T&P)** consists of the following divisions: Building Inspection (including electrical, mechanical and plumbing), Code Assistance, and Engineering.

Building Inspection and Code Assistance are responsible for all permit issuance; inspection of all work related to construction projects or structures in the City; enforcement of the zoning ordinance; and investigation of alleged ordinance and code violations related to City parking lots, signs, nuisances and offensive conditions, blight, garbage and rubbish containment, weeds and rodent control, dog pound and animal control, and certain types of parking offenses.

The Engineering Division oversees all matters related to construction of the physical properties of the City's infrastructure, as well as planning and engineering services for the City.

### ANIMAL CONTROL

- Residents can own up to three animals.
- All dogs and cats must be licensed and on a suitable leash (or, in the case of cats, on a harness) while off owner or custodian premises, including public parks. Dogs or cats can also be properly confined in a closed vehicle or a travel receptacle.
- Owner must remove all droppings in public spaces.
- Lost pets are held up to four days in the City pound, located on the Department of Public Works grounds at 10600 Capital St., Oak Park. Hours of operation are Monday thru Friday, 8 a.m. to 5 p.m. Summer hours changes to 10:30 a.m. to 7 p.m. A daily charge is due when the pet is picked-up.
- The City does **NOT** provide animal removal (i.e., raccoons, birds or bats) from properties. Residents will need to secure a private contractor.
- If you are bitten by an animal, contact Animal Control between 8 a.m. and 5 p.m. Contact Public Safety at (248) 691-7520 between 5 p.m. and 8 a.m.

### CODE ASSISTANCE

- Contact Code Assistance to report:
  - Abandoned vehicles on occupied property. If the abandoned vehicle is not on occupied property, such as the public street or vacant property contact T&P. If the abandoned vehicle is on a public street or vacant property, contact Public Safety.
  - Abandoned houses
- Rentals: Landlords must purchase an annual rental license to register properties with the City. Properties must be inspected by Code Assistance every two years or with occupancy change.
- A ticket issued by Code Assistance constitutes a civil infraction.





## TECHNICAL AND PLANNING (T&P)

### BUILDINGS

- **Building Permits:** Residents and businesses are required to obtain building permits for:
  - Plumbing, mechanical or electrical work
  - Additions and/or alterations to existing structures
  - Any work performed in the public right-of-way
- **DIY Home Improvements:** Contact the Building Inspector to discuss your options.
- **Financial Assistance:** Residents who qualify with low-to-moderate income can contact Oakland County Home Improvement Loan Programs for home repairs.

**ADVANTAGES:** One of the benefits of permits is that it involves the services of a professional inspector who approves each phase of the construction process which results in a safe and accurate process.

### FAQ (Frequently Asked Questions)

#### *How do I check property zoning?*

- The Planning division can assist by reviewing the City's official Zoning District Map, which is also on the City's website as Appendix A of the City Code. Additional maps can also be purchased from T&P.

#### *Can I operate a business from my home?*

- The City's Zoning Ordinance allows for certain "home occupations" to be conducted at a residence. The Planning division can assist in determining eligibility.

#### *How do I turn a large property into two parcels?*

- The City Assessor reviews and approves all lot splits and combinations. The Planning Division can assist in identifying Zoning Ordinance requirements.

#### *Am I allowed to display a temporary sign or banner?*

- City Council reviews and approves all requests for temporary signs and banners. See T&P for an application.

#### *Before I dig holes in my yard to plant trees or install a fence, how do I identify water or sewer line locations?*

- Call 1-800-MISS DIG for this information.

### ENGINEERING

- Contact Engineering to report:
  - Burned out street lights
  - Malfunctioning traffic signals
  - Dangerous sidewalks
  - Water leaks on public property
- **Water Leaks:** Residents are responsible for repairing water leaks on private property.
- DPW generally notifies residents in advance of major street, sidewalk, water, or sewer projects. To learn more about planned improvements to the City's infrastructure, contact the Engineering Department.

## COMMUNITY AND ECONOMIC DEVELOPMENT (CED)

**The Community and Economic Development Department** works with Oak Park businesses and entrepreneurs to attract and retain a strong business base in the community. CED offers business support, as well as programs designed to enhance quality of life within the community.

#### FAQ - GENERAL

##### ***How is fiscal policy set in Oak Park?***

- The City Manager, with City Council approval, sets fiscal policy. The Annual Budget is available for public review in the Oak Park Library, the City Clerk's Office, the Finance Department in City Hall, and online on the City's website.

##### ***How can I do business with the City?***

- Current contracts up for bid are posted on the Michigan Inter-governmental Trade Network ([www.mitn.info](http://www.mitn.info)).



## FINANCE AND ACCOUNTING

**Oak Park Finance and Accounting** consists of the following public divisions :

**Assessing** determines the value of all Oak Park properties for taxation on an annual basis. This division collects and provides public access to the following information: taxpayer of record information, principal residence exemption (PRE) status, physical improvements to the land, lot sizes, property descriptions, sales data, drawings, maps and businesses located within the City.

**Treasury** is responsible for collecting all monies payable to the City, including taxes, permit fees, license fees, and miscellaneous receivables. This excludes building permits and licenses.

**Water Department** facilitates residential and commercial services, which include water, sewage removal, garbage pickup and water system maintenance.

### FAQ - ASSESSING

#### ***What do the terms "assessed value" and "taxable value" mean?***

- Assessed Value is generally one-half of the market value of the property, as determined by a two-year sales study. The term "state equalized value" or SEV simply means the Assessed Value as confirmed by the State of Michigan. Taxable Value is the amount on which your property taxes are levied. Taxable Value is capped and can only change by the rate of inflation each year (or 5%, whichever is less), unless a property has had a Transfer of Ownership in the prior year or had physical changes to the property.

#### ***Why are my taxes higher than my neighbor's taxes when our houses seem so similar?***

- Taxes are based on taxable value, not assessed value.

#### ***What is a "Homestead Exemption"?***

- This is an exemption from paying 18 mills in school operating tax. For eligibility, you must own and occupy the home and have a valid Principal Residence Exemption (PRE) on file with the Assessor's Office.

#### ***What should I do with the Notice of Assessment I receive by mail each March?***

Review it. Contact the Assessor with any questions. Maintain the notice in preparation for your tax returns next year.

## FINANCE AND ACCOUNTING

### FAQ - TAXES

#### ***When are taxes due?***

- Summer (City) taxes are due between July 1 and August 31. Winter (County) taxes are due between December 1 and February 14.

#### ***How can I pay my tax bill?***

- Online payments using a credit card can be made 24 hours-a-day on the City's website at [www.oakparkmi.gov](http://www.oakparkmi.gov). Credit card payments are accepted online and at the counter in City Hall. Tax bills may also be paid with cash, check, or money order delivered by mail, in-person at the counter in City Hall, or by using the drop box outside City Hall, located at 14000 Oak Park Blvd., Oak Park, MI.

#### ***What if I cannot pay my taxes on time?***

- The City of Oak Park will accept payments for summer taxes without penalty through August. In September, there will be a 4% penalty charged to all unpaid summer taxes. Beginning in October, an additional penalty of one-half of 1% per month will also be assessed, not to exceed 6%.
- Winter taxes paid after February 14 will incur a penalty of 3%.

#### ***Will a partial payment be accepted on tax bills?***

- Yes. A partial payment option is available. Please contact the Treasury Department at (248) 691-7545 for details.

### FAQ – WATER

#### ***How can I pay my water bill?***

- Online payments using a credit card can be made 24 hours-a-day on the City's website at [www.oakparkmi.gov](http://www.oakparkmi.gov). Credit card payments are accepted online and at the counter in City Hall. Water bills may also be paid with cash, check, or money order delivered by mail, in-person at the counter in City Hall, or by using the drop box outside City Hall, located at 14000 Oak Park Blvd., Oak Park, MI. Payments on past due accounts that have been disconnected or issued a blue disconnection notice must be paid in cash or money order.

#### ***Does the Water Department sell garbage bags and trash containers?***

- Yes. Subject to availability, Water Services sells garbage bags and recycling bins. Occasionally, Oak Park purchases regulation-size, 95-gallon trash carts at a discount, which we pass on to our residents on a first-come, first-served basis. Watch for sale announcements in the City's newsletter, the *Oak Park Magazine*. Prices are subject to change, so please call (248) 691-7470 for details.

### WATER BILLING

#### **How do I calculate my water bill?**

Water bills are determined by the amount of water that passes through your water meter multiplied by the current water and sewer rates. For example, if you receive a bill and in the "used" column you are billed for 25 units of water, we would calculate your water bill as follows:

$$\text{Water (WT)} = 25 \times 4.25 = \$106.25$$

$$\text{Sewer (SW)} = 25 \times 10.53 = \$263.25$$

$$\text{Typical Meter Charge} = \$4.75$$

$$\text{Garbage/Rubbish Charge} = \$38.72$$

$$\text{Total} = \$412.97$$

There are several ways residents can work to reduce their water bills:

- Check leak detectors often
- Fix running toilets and leaky faucets
- Instead of waiting for your water bill every three months, try budgeting for it monthly and pre-paying it monthly
- Shorten shower times, turn off water while brushing teeth, and find other ways to reduce water usage

## PERMITS AND LICENSES

Upon payment of any applicable fees, the City Clerk issues permits and licenses as required by law:

- Merchants: Expires annually. Fees vary.
- Garage sales: Two individual sales allowed per year, no more than five consecutive days. Check for free garage sale weekends in the summer months!
- Lawn care/Snow Removal: Expires annually
- Taxi cab: Expires annually
- Handbills: Various fees
- Sidewalk sales: Two sales allowed per year, no longer than three days each.
- Vendor's: Expires annually
- Mechanical amusement device: Expires annually
- Distributors: Expires annually
- Going-out-of-business: Fees vary.
- To maintain a real estate non-solicitation list: List updated each time a new solicitation is submitted.
- Precious Metals Licenses: Fees vary.
- Special Events (such as a parade, bike race, 5K run, or neighborhood block party)

## OFFICE OF THE CITY CLERK

**The Office of the City Clerk** is the information center of the City. As a professional liaison between the City, its residents and the public, the Clerk's Office provides various services on a daily basis for the community while maintaining neutrality and impartiality. This allows the office to render equal service to all while maintaining the integrity of all elections and public records of the City of Oak Park.

The City Clerk's Office is responsible for providing services for the City Council and the Council-appointed boards and commissions of the City (see page 8). The Office is responsible for coordinating all election activity in the City and issues specialty licenses and permits. Other duties of the Clerk's Office include records management, mail processing, public notice administration, bid openings and Freedom of Information Act (FOIA) request coordination.



## RESIDENTIAL SALE REQUIREMENTS

Permits are required for any residential sale in Oak Park, including garage, estate, moving, basement or yard sales. Residents are limited to two sales (total) per year. Fees vary.

### ABSENTEE BALLOTS

Absent voter ballots are available to registered voters for all elections. They provide a convenient method for casting a ballot when a voter is unable to attend the polls on election day.

To receive an absentee ballot, you must complete the required application, which can be found at [www.oakparkmi.gov](http://www.oakparkmi.gov) or at the City Clerk's Office.

Return your application to the Clerk's Office by mail or drop it off in-person.

Ballots are mailed within 24 hours of receipt.

The City Clerk maintains a list of absentee voters for every regularly-scheduled primary and general election. Any registered voter is eligible to be added to this list. To be added, contact the City Clerk's Office.

## FAQ – Library

### *How do I get a library card?*

You are eligible if you either live in Oak Park or are an employee of the City of Oak Park. Bring proof, complete the registration process, sign your card, and you're all set!

### *Can my child get a library card?*

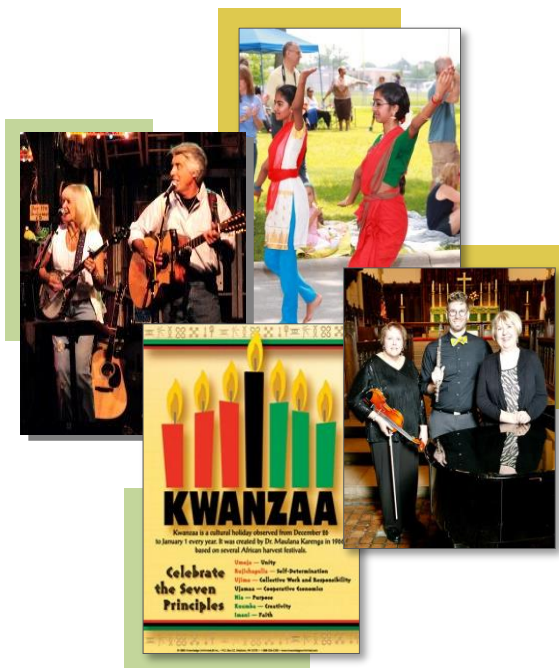

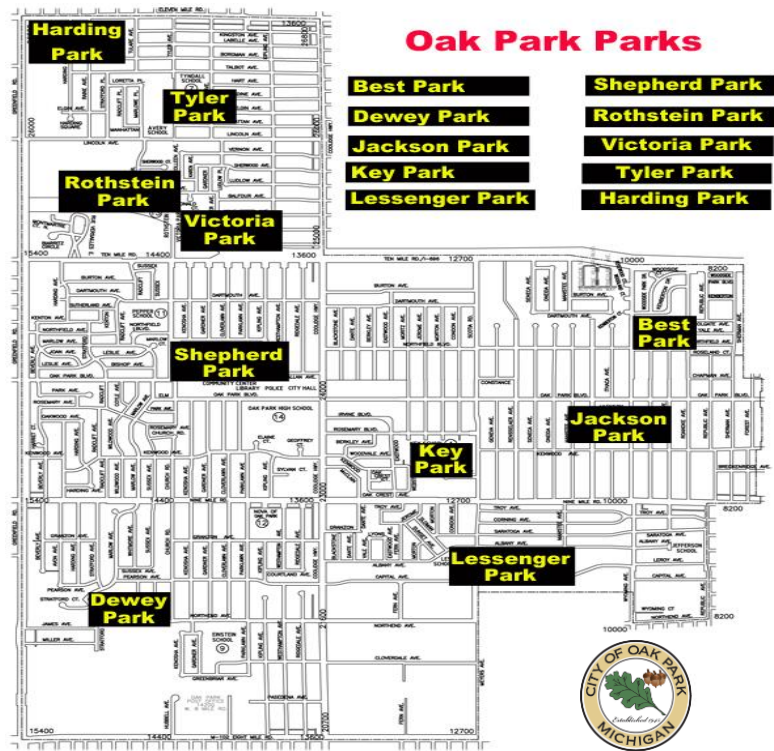

## PUBLIC SAFETY

The Oak Park Public Safety Center has an accomplished history of service to the community since being established in 1954. Responding to more than 15,000 service calls each year, the department continuously seeks to improve the quality of life in Oak Park by working in partnership with all citizens to protect life and property, to promote safety, to maintain public order and to preserve human rights.

### FAQ – General

#### How do I report an emergency?

Call 9-1-1 for fire, medical, or police response, or any life or property-threatening emergency.

#### Where is the Public Safety Center located?

The Oak Park Public Safety Center is located at 13800 Oak Park Blvd., Oak Park, MI 48237. City Hall's and the Public Safety Department's entrances are West of Coolidge, between 9 Mile Road and 10 Mile Road, on the north side of Oak Park Blvd. opposite Oak Park High School. From I-696, use Exit 14, turn south on Coolidge and travel one-half mile to Oak Park Blvd. Business phone: (248) 691-7520. Emergency: 911

#### What are the Public Safety Center hours?

The Public Safety Center, Uniformed Patrol, is open 24 hours a day, 365 days a year. The Administration, Investigations, Fire Inspection, Records and Property offices are open Mon. – Fri. between 8 a.m. and 5 p.m.

#### Is there a way to report a crime anonymously?

In most cases, crimes may be reported anonymously. Formal crime reports are not accepted over the phone, however, so victims must appear in person. Names, addresses, and telephone numbers are not required to complete a crime report at the Public Safety Center.

#### Is there a charge for using paramedic services?

There is a charge if the patient is transported. There may be a nominal fee if medical technicians make a vitals assessment and determine transport is not necessary or if the callers decide to transport the patient themselves.

#### Who do I contact about having a special event, such as a parade, bike race, 10K run or neighborhood block party?

## PUBLIC SAFETY

### What is available at the Public Safety Records Bureau?

Alarm permits, gun permits, bike licenses, fingerprints, personal record clearance, vehicle inspections, parking permits, and applications for carrying a concealed weapon are available through the Public Safety Records Bureau. The Records Bureau is also your source for police reports and crash reports. All requests must be made in writing. The release of information is subject to Michigan Freedom of Information Act guidelines.

### Where do I get a gun permit ?

Changes in the State of Michigan gun laws now allow a citizen to purchase a handgun directly from a licensed gun dealer (i.e. gun shop). Those wishing to purchase a handgun from a private seller must still obtain a license to purchase a permit if they do not possess a Concealed Pistol License. Government-issued identification and one other form of identification is required at the time of application. Please contact the Records Bureau for the fee schedule.

### Where can I get an alarm permit and how much does it cost?

Alarm permits may be obtained from the Public Safety Records Bureau for a one-time \$20 fee. Applications for an alarm permit are also available on the city website at [www.ci.oak-park.mi.us](http://www.ci.oak-park.mi.us).

### Can I park a large truck in front of my house? Is there somewhere else I can park it?

City ordinances prohibit the parking of commercial vehicles on the public roadway in residential areas. Restrictions also apply in some instances on private property. Please review the city ordinance (available online). Parking of commercial vehicles, by permit only, is allowed in the municipal parking lot off of Eleven Mile Rd, between Tulare and Gardens Streets. Please contact the Records Bureau for permit specifics.

### Where do I obtain a bicycle license ?

Bike licenses are available at the Public Safety Records Bureau for a \$2.00 fee.

### Where can I obtain an animal license and how much do they cost?

Animal licenses (dog and cat) are available for purchase at the Public Safety Records Bureau. The application for an animal license is also available on the city web-site ([www.oakparkmi.gov](http://www.oakparkmi.gov)). Fees vary depending on whether the animal is spayed/neutered and if a one- or three-year license is being sought (dependent on the rabies vaccination certificate). Applicants will need to present a Rabies Certificate from the vet, along with proof of neutering, if applicable.



#### ONE YEAR Animal License

Spayed / Neutered: \$7.00  
Non-Spayed / Neutered: \$16.00

#### THREE YEAR Animal License

Spayed / Neutered: \$15.00  
Non-Spayed / Neutered: \$30.00

Except for licenses for newly acquired animals, most animal owners should purchase their licenses between October 1 and December 31 for the following calendar year in order to avoid late fees.
