GENERAL INFORMATION:

- Total lot coverage (includes all buildings) shall not exceed 35% of square footage of the lot
- Structures shall not exceed 13' in height at the point half-way between the peak and the eave of the roof
- Only one main building (house) and one accessory building (garage or shed) greater than 200 sf are allowed per residential lot. See City Code Article 17 Section 1703(b)
- Structure shall be no closer than two (2) feet to a side lot line. Rear lot easements (typically 6 feet from rear lot line) must be maintained unless written permission from the utility company allowing encroachments are submitted. On corner lots, a setback of 15' must be maintained from the corner.
