\*For open road cuts, a maintenance guarantee of \$2,000.00 will be paid to the Town of Ogden. Upon the satisfactory completion of the job within the approved time frames and in conformance with the approved plans, the monies will be returned to the permittee. This will follow an approval of the work by the Town of Ogden Highway Department at six months, but no more than one year, after the completion of the job. Failure to make the required repairs to the satisfaction of the Highway Department within the one-year period will result in the forfeiture of the guarantee.

\*It is the Town of Ogden Highway Department's policy that a 149 highway permit be obtained by the contractors, builders or property owners before the installation of any driveway off of a town roadway within the Town of Ogden. (All criteria for approval is listed on the 149 permit.) When issuing a 149 highway permit for the installation of the driveway from a roadway where gutters are located, a \$40.00 non-refundable permit fee is collected, as well as a \$2,000.00 gutter escrow. The gutters are inspected by town personnel before the driveway is installed, and the condition of said gutters is noted on the permit (existing cracks or any other damage). A certificate of liability insurance listing the Town of Ogden as additional insured is required.

\* For existing driveway work a certificate of liability insurance listing the Town of Ogden as additional insured is required.

Once the driveway is installed per subdivision plan and town design criteria, and the certificate of occupancy is issued, town personnel will once again inspect the gutters. If any new damage is found, it will be repaired by the highway department and funded by the gutter escrow being held. The difference will be refunded to the permit holder once the repairs have been made. If no additional damage has been found with the gutters, the full \$2,000.00 escrow will be refunded.
