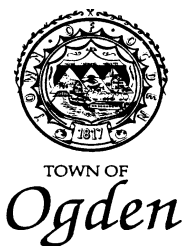

**TRUCK OR CONTAINER/ROLL-OFF RENTAL AGREEMENT FOR BRUSH, CONCRETE, & DIRT**

The Town of Ogden has 10-yard container/roll-off or truck rental service, which is available to its residents. In order to rent a container/roll-off or truck you must comply with the following rules:

- 1) Pay a fee of \$40.00 for fuel and other related truck and container/roll-off expenses.
- 2) **Cement, concrete, dirt, and brush** are the only items that can be placed in the truck or container/roll-off and the materials cannot be mixed. (1 material per container) **Absolutely no** building/construction materials, garbage, tires, liquids of any kind, cans, drums, metals, bottles, box springs, mattresses, upholstered chairs, couches, appliances, paper, or cardboard. These items are not acceptable and therefore, must not be placed in the container/roll-off.
- 3) Containers/roll-offs must be loaded by hand and not any type of machinery. Trucks can be loaded by machinery.
- 4) **This is a residential service ONLY! IT IS NOT TO BE USED FOR COMMERCIAL ENTERPRISE OR CLEARING OF LOTS!**
- 5) The container/roll-off/truck will be delivered to and placed at the resident's location by an employee of the Highway Department. It will then be loaded by the resident and picked up by the Highway Department the following day.
- 6) Requests for truck/container/roll-off rental will be on a first come first serve basis, subject to the availability of the delivery truck and the containers/roll-offs and general convenience of the Highway Department.
- 7) **Material to be loaded, and rental of the equipment is at the discretion of the Highway Superintendent and requires his approval.**

In signing the following statement, you agree to the terms of this agreement as stated above. In consideration of the Town of Ogden placing their container/roll-off on the premises at \_\_\_\_\_ so as to allow me (us) to load the same with debris. I (we) do hereby agree to indemnify, defend and save the Town of Ogden harmless from any and all claims of any kind or nature whatsoever, including personal injury and/or property damage arising out of the placing of the truck/container/roll-off on my (our) property, and/or the use of the same by me/us for loading of debris. Any damage done to the truck or container/roll-off will be the responsibility of the undersigned.
