The Otsego Lake Township Special Board Meeting was called to order at 9:00 a.m. by Supervisor Matelski with the Pledge of Allegiance.

Motion made by Jerry Brown to appoint Mary Brown to take meeting minutes; second by Jerry Brown; **MOTION CARRIED**

Board Members present: Dave Matelski, Gary Johnson, Jerry Brown & Mary Brown

5 guests were present

There were no conflicts of interest and no additions to the agenda.

Supervisor Matelski advised that Mary Brown has a written notice of interest to be appointed to the vacant clerk's position, he also has talked with two other people with no interest, Gary Johnson talked with three other people with no interest. There was much discussion on the urgency of filing the Clerk's position. Jay W. advised his opinion is that MTA is wrong on the primary rules, the clerk would not have to run in the next primary election. Randy S. read some of the MC information on election rules and said the clerk serves until 2024. Jay W. expressed concerns that we do not have to go through a recall.

Supervisor Matelski has contacted township attorney for legal opinion on election rules, waiting for an answer.

Roll call vote: Jerry Brown: Yes; Gary Johnson: Yes; Dave Matelski: Yes; Mary Brown: Yes


MOTION CARRIED
