No one claims ownership, it is a potential liability and a nuisance to neighboring properties. Several people have called complaining to the supervisor and after researching, he recommends having the property surveyed to determine who owns it. Motion made by Jerry Brown to have Wade Trim do a survey not to exceed \$1,000.00, second by Mary Brown; Baker voted NO; **MOTION CARRIED**

Fire Chief Dale Tucker's annual contract was reviewed. Motion made by Jerry Brown to renew annual contract from April 1, 2022 until March 31, 2023, second by Mary Brown; **MOTION CARRIED**
