December 15, 2022

The Otsego Lake Township meeting was called to order with the Pledge of Allegiance at 7PM by Supervisor Matelski. All board members were present, there were 15 guests.

Supervisor Update: Dave gave updates on gravity rail at park, reminder to all board members to use Township email, not personal, met with Road Commission today and discussed roads in the township.

NEW BUSINESS: Thomas Marquard, Otsego County Zoning Director gave an update on the maintenance on Iron Belle Trail, explaining the billing breakdown by townships. The County Park has applied for a SPARK Grant to enhance the playground equipment & beach area.

Jay Welter questioned the authority of the Supervisor on nominating members to BOR, the proper procedures were followed.

All BOR members must take Oath of Office by December 25th.

COUNTY COMMISSIONER: Rob Pallarito reported ON County Bus ridership has gone back up, the County did approve a second full time dispatcher. The County also approved the Sheriff Department to purchase a new van for the work camp. Rob has accepted a position as District Director for Senator Hoitenga, we wish him much success. Supervisor Matelski presented Commissioner Pallarito with a Certificate of Appreciation for his time serving as County Commissioner representing Otsego Lake Township.

PUBLIC COMMENT:

Rob Pallarito commented that officials need to wait for the process on the expansion, it is going to be around two years to sort the property details out before we have any facts.
