ARTICLE 3. BUDGET FOR FISCAL YEAR 2026 - \$19,047,184

To see if the Town will vote to raise and appropriate the sum of Nineteen Million, Forty-Seven Thousand, One Hundred Eighty-Four Dollars (\$19,047,184) for the support of General Municipal, Water, and Wastewater Operations. This represents the fiscal year 2026 budget period, July 1, 2025 to June 30, 2026. This article does not include appropriations in special or individual articles addressed separately.

The Select Board recommends this appropriation by a vote of 3-0 The Budget Committee recommends this appropriation by a vote of 8-0

ARTICLE 4. PAY-AS-YOU-THROW SPECIAL REVENUE FUND - \$113,672

To see if the town will vote to raise and appropriate the sum of **One Hundred Thirteen Thousand Six Hundred Seventy-Two Dollars (\$113,672)** for the purpose of operating and maintaining the Town's Pay-As-You-Throw program, with said funds to come from Pay-As-You-Throw Special Revenue Fund and no additional funds to be raised through taxation.

ARTICLE 5. POLICE DEPARTMENT FLEET MANAGEMENT CAPITAL RESERVE FUND - \$125,000 To see if the Town will vote to raise and appropriate the sum of One Hundred Twenty-Five Thousand Dollars (\$125,000) to be placed in the previously established Police Department Fleet Management Capital Reserve Fund.

ARTICLE 6. FLEET MANAGEMENT CAPITAL RESERVE FUND - \$300,000

To see if the Town will vote to raise and appropriate the sum of **Three Hundred Thousand Dollars** (\$300,000) to be placed in the previously established Fleet Management Capital Reserve Fund.

ARTICLE 7. ROADWAY SYSTEM UPGRADES CAPITAL RESERVE FUND - \$400,000

To see if the town will vote to raise and appropriate the sum of **Four Hundred Thousand Dollars** (\$400,000) to be placed in the previously established Roadway System Upgrades Capital Reserve Fund.

The Select Board recommends this appropriation by a vote of 3-0 The Budget Committee recommends this appropriation by a vote of 8-0

ARTICLE 8. BRIDGES, CULVERTS, AND DAMS EXPENDABLE TRUST FUND - \$400,000

To see if the Town will vote to raise and appropriate the sum of Four Hundred Thousand Dollars (\$400,000), to be placed in the previously established Bridges, Culverts, and Dams Expendable Trust Fund.

The Select Board recommends this appropriation by a vote of 3-0 The Budget Committee recommends this appropriation by a vote of 8-0

ARTICLE 9. ADAMS POOL IMPROVEMENT CAPITAL RESERVE FUND - \$35,000

To see if the Town will vote to raise and appropriate the sum of **Thirty-Five Thousand Dollars** (\$35,000) to be placed in the previously established Adams Pool Improvement Capital Reserve Fund.

The Select Board recommends this appropriation by a vote of 3-0 The Budget Committee recommends this appropriation by a vote of 8-0

ARTICLE 10. AMBULANCE SERVICE REVOLVING FUND - \$375,000

To see if the town will vote to raise and appropriate the sum of **Three Hundred Seventy-Five Thousand Dollars (\$375,000)** to be placed in the Ambulance Service Revolving Fund.

ARTICLE 11. WEST PETERBOROUGH DISTRICT EXPENDABLE TRUST FUND – \$1,227,194.34
To see if the town will vote to raise and appropriate the sum of One Million, Two Hundred Twenty-Seven Thousand, One Hundred Ninety-Four Dollars and Thirty-Four Cents (\$1,227,194.34) from the West Peterborough Tax Increment Finance District taxes collected, to be placed in the previously established West Peterborough District Expendable Trust Fund, no additional funds to be raised through taxation.

The Select Board does not recommend this appropriation by a vote of 2-1 The Budget Committee recommends this appropriation by a vote of 6-0-2

ARTICLE 16. TERMS OF COMPENSATION FOR ELECTED OFFICIALS - \$3,960

To see if the town will vote to amend the annual terms of compensation for the elected Treasurer and appointed Deputy Treasurer as follows:

- Treasurer from \$2,040 a year to \$5,000 a year
- Deputy Treasurer from \$1,500 a year to \$2,500 a year

And, furthermore, to raise and appropriate the sum of Three Thousand, Nine Hundred Sixty Dollars (\$3,960) as the cost associated with this warrant article for fiscal year 2026.

ARTICLE 17. ELDERLY TAX EXEMPTION AMOUNTS

- For a person 65 years of age up to 75 years, 100,000
- For a person 75 years of age up to 80 years, 150,000
- For a person 80 years of age or older, 200,000

ARTICLE 18. DISCONTINUE A PORTION OF BASS ROAD - BY PETITION

To see if the Town will vote pursuant to RSA 229:5, VII and RSA 231:45 to change the classification of a portion of Bass Road starting at the intersection of Bass Road with Wilton Road (Route 101) to the easterly boundary line of Tax Map R002, Lot 41 from a Class V highway to a Class VI highway subject to gates and bars. Said portion of Bass Road having approximately 952 feet of linear frontage. If approved, this reclassification would prevent the discontinued portion of Bass Road from being used as a throughway by motor vehicles between Elm Hill Road and Wilton Road. By Petition.
