NOTICE is hereby given that the next meeting of the Oak Grove town board shall begin at 7:30 p.m. on **Tuesday, April 16**, to follow the Town's annual meeting. **The regular April 15 board meeting has been cancelled.** (No quorum is anticipated on Monday, April 15, and no action shall take place on April 15 other than to adjourn the board meeting to April 16.)

The April board meeting has the following agenda. Any updates to this agenda shall be posted at least 24 hours before the meeting. The Annual Meeting begins at 7 p.m. on April 16 (separate meeting notice).

Meetings are held at the Oak Grove town hall, located at N4939 1100<sup>th</sup> St., 54021. Members of the public are always welcome.

2. Review and approve prior minutes.
3. Public Comments: Brief comments from citizens regarding topics not on the current agenda. Items may be submitted for future agenda. No formal action.
4. **Road Projects: 1208<sup>th</sup> St and 570<sup>th</sup>.** Continue review of design plans for the **1208<sup>th</sup> St.** reconstruction (spillway and adjacent roadway), scheduled for completion 2025. Review **570<sup>th</sup> Ave.** project plans and progress (replacement of culvert and overlying roadway), scheduled for completion 2024. Engineering consultant slated to attend. Discuss/take action.
5. **ARIP:** Updates regarding grant application.
6. **Ordinance 2024-01, Snowmobile Route (550<sup>th</sup> Ave.):** Request by the Sno-Bees club to establish a Route permitting snowmobile travel on 550<sup>th</sup> Ave. off 1090<sup>th</sup> St., linking trails. Discuss/take action on proposed ordinance.
7. **Riprap Cost (435<sup>th</sup> Ave.):** Discuss/take action on the option to recoup the cost of restoring riprap removed from the public right-of-way on 435th through billing of the landowner responsible.
8. **Annual Plan Commission Appointment:** Appoint one board member. (Purs. Oak Grove code sec. 1.20, one supervisor shall be elected to the commission by two-thirds vote each April.)
9. **Annual Fire & EMS Assoc. Appointment:** Appoint two Oak Grove representatives. (Purs. the Association agreement, two Oak Grove representatives shall be appointed annually by May 15 to serve a one-year term from June 1 to May 31. Representatives may be citizens and/or town officials.)
10. **Valley/Hwy. 10 Access:** Discuss/take action to approve a temporary-access permit for the Valley Bar & Grill during 2024 Hwy. 10 reconstruction, allowing motor vehicles and ATVs/UTVs to reach the restaurant parking lot from the intersections of Hwy. 10 and 1040<sup>th</sup> St. and Hwy. 10 and 570<sup>th</sup> Ave.
11. Building Inspector's monthly report: Approve construction damage bonds submitted for release.
12. Bills: Approve payments due.
13. Treasurer's report.
14. Travel/training requests.
15. Roundtable Updates: Officials exchange brief updates regarding topics not on the agenda such as projects in progress, outside meetings/calendar items, correspondence. Items may be suggested for upcoming agenda. No formal action.
