Chapter 10.20 of the Pierce County Code is hereby repealed.







ORDINANCE NO 83-6

AN ORDINANCE IMPOSING A PENALTY OF ONE-HALF OF ONE PER CENT PER MONTH
ON OVERDUE OR DELINQUENT REAL ESTATE TAXES AND SPECIAL ASSESSMENTS

The County Board of Supervisors of the County of Pierce does ordain as follows:

SECTION I.

Pursuant to the authority of Section 74.80(2), Wisconsin Statutes, there is hereby imposed a penalty of 0.5 per cent per month or fraction of a month, in addition to the interest provided for in Section 74.80(1), Wisconsin Statutes, on all real estate taxes and special assessments that are overdue or delinquent on and after January 1, 1984.

SECTION II.

The County Treasurer shall exclude the additional revenue generated by this penalty from the distributions required by Section 74.03(7), Wisconsin Statutes, and Section 74.031(12)(c), Wisconsin Statutes, and Section 74.031(12)(d), Wisconsin Statutes.

SECTION III.

This Ordinance shall take effect and be in force from and after its proper passage and publication pursuant to Wisconsin law.

Resolution Establishing Fees For Forms Made Available To Members Of The Public
By The Office Of The Register In Probate And Establishing Fees For Forms Provided
To Members Of The Public By The Office Of The Register In Probate.

TO THE HONORABLE BOARD OF SUPERVISORS
FOR PIERCE COUNTY, WISCONSIN

GENTLEWOMEN AND GENTLEMEN:

WHEREAS, the Office of the Register In Probate, in keeping with the general practice of such offices, makes available to members of the Public and provides to members of the public forms required for use in the processing of the different types of matters heard by the Pierce County Circuit Court, Probate Branch; and,

WHEREAS, Section 59.07(5), Wisconsin Statutes, and Section 59.07(6), Wisconsin Statutes, confer upon the Pierce County Board of Supervisors general authority to manage the business and concerns of Pierce County, Wisconsin, in all cases where no other provision is made and to prescribe the form and manner of keeping the records in any Pierce County, Wisconsin, Office; and,

WHEREAS, the Law Enforcement Committee of the Pierce County Board of Supervisors is informed and believes that it will provide for more efficient operation of the Office of the Register In Probate, and provide for continued beneficial service to members of the public, if fees are established for the forms made available to members of the public by the Register In Probate, and if fees are established for the forms provided to members of the public by the Register In Probate, as follows:

1. Forms for probate and formal administration and informal administration -- \$4.76;
2. Forms for summary settlements and summary assignment proceedings -- \$2.86;
3. Forms for guardianship and conservatorship proceedings -- \$1.90;
4. Forms for termination of joint tenancy, termination of life estate, certificate of descent proceedings, adoption proceedings, and special administration -- \$0.95.

SO, NOW, THEREFORE, BE IT RESOLVED, By the Pierce County Board of Supervisors, that the Office of the Register In Probate be and hereby is authorized and directed, effective January 1, 1984, to promulgate and charge fees for forms made available to members of the public by that office, and for forms provided to members of the public

by that office, in accordance with the amounts and categories set forth above, which fees shall be payable upon the filing of the document or documents by which the respective legal proceeding is commenced, or as otherwise may be specified by the Office of the Register In Probate, who shall pay over to Pierce County, Wisconsin, all such fees received.



FARMLAND PRESERVATION AGREEMENTS

WHEREAS, The Pierce County Planning & Zoning and Pierce County Agriculture Extension & Educational committees have been designated by the County Board of Supervisors to review and make recommendations on Farmland Preservation Agreement applications, and

WHEREAS, applications of the below listed applicants have been referred to the required agencies for a 30 day review period, and comments from said agencies have been considered, and

WHEREAS, the lands of said applicants meet the eligibility requirements of the law, namely;

1. The land is 35 acres or more.
2. The land produced gross farm profits (as determined in accordance with Federal Schedule F) of \$6,000. or more in the previous year, or \$18,000. or more in the previous 3 years.
3. The land was in agricultural use for at least 12 consecutive months during the preceding 36 months.
4. The land was used for one or more of the following: Beekeeping; dairying, egg production; floriculture; fish or fur farming; forest and game management; grazing; livestock raising; orchards; plant greenhouses and nurseries; poultry raising; raising of grain, grass, mint and seed crops; raising of fruits, nuts and berries; sod farming; vegetable raising and commercial feedlots.
5. The land is owned by a resident of the state. An "Owner" includes an individual, legal guardian, corporation, incorporated in Wisconsin, business trust, estate, trust, partnership or association of 2 or more persons having a joint or common interest in the land. Where land is subject to a land contract, "owner" means the seller in agreement with the buyer.
6. A soil and water conservation district conservation plan is in effect or has been applied for, and
7. Landowner must include all existing tillable cropland according to Resolution No. 77-71.

WHEREAS, the land of said applicants meet the County's approved standards for approval, based on criteria specified in Sec. 91.13(4) relating to agricultural productivity, agricultural use, extent of contiguous ownership entered, consistency with existing Ag Preservation plans, or other criteria established by County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED:

That the following named applicants for Farmland Preservation Agreements under Ch. 91 of the Wis. Stat. be approved by the Pierce County Board of Supervisors for participation in the Farmland Preservation Program: (See attached list)

That the applications of the named applicants be forwarded to the Wisconsin Department of Agriculture, Trade and Consumer Protection for preparation of Farmland Preservation contracts.
