Budget: There is approximately \$45,000 left in our checking account from last year. We did not get to all of the road work we had hoped to have done. Bruce Plante said he is not comfortable with that much surplus and would like to see us only carry over \$25,000.

Bruce made a motion to reduce the levy by \$21,000 and reduce the road budget down by \$20,000. Charisse seconded the motion. Discussion: It was discussed that this could potentially put the town in financial difficulties again if an unforeseen issue came up with a road. It was suggested that it would be better to plan on using the surplus and getting some much-needed work done than to reduce the levy. Bruce suggested we need to put in writing road work priorities. Motion failed.

Ron Bartels made a motion to approve the budget but with an additional \$20,000 for road projects. Charlie Brown seconded the motion. Vote was taken Ayes 5

Nays 2

Motion carried.

The following are minutes of the November 4, 2019, special meeting of the Board of the Town of Isabelle to discuss the various road projects:

Dennis Potts called the meeting to order at 12:05 PM. Those present included Bruce Plante, Dennis Potts, and Ron Bartels. Charlie Brown joined the meeting at 12:20 PM.

The various options regarding brushing and ditching were discussed at length.

The Pierce County Highway Department has been requested to complete all brushing on 150th Avenue, 560th Street, 135th Avenue adjacent to the former green house, 530th Street, and 570th Street N. The Highway Department has been advised that 150th Avenue must be completed before snow plowing activity begins.

Charlie Brown made a motion that ditching using a road grader shall be performed on both sides of the northern portion of 545th Street, the east side of the southern portion of 545th Street, 570th Street S and 570th Street N in that order. The motion was seconded by Ron Bartels. Motion carried by voice vote.

It is expected that this ditching cost will not exceed \$3,000. The results and costs will be reviewed as the work is performed. This work will help determine if and when excavation via backhoe and hauling via truck will be required to get the desired result. Seeding will be delayed until next spring.
