Budget: There is approximately \$82,000 left in our checking account from 2020. We did not get to all of the road work we had hoped to have done. We have gotten bids from Pierce County for road work we would like to have done in the next year.

Dennis Potts and Ron Bartels representing the Town of Isabelle met with Chad Johnson and Elliott Check of the Pierce County Highway Department at 9:30 AM on Wednesday, September 30, 2020. The purpose of the meeting was to discuss various road maintenance projects in the Town of Isabelle.

Items discussed included:

1. Brushing –
 - a. 170th Avenue west of County Road D
 - b. 560th Street continuing onto 130th Avenue
 - c. 570th Street (King Hill)
 - d. 730th Street (just off 135th Avenue)
2. TRIP Funding
 - a. Potential funding starting in 2022 not 2021
 - b. Seal coating qualifies for such funding if double seal coated
3. Seal coating
 - a. Single seal coating is \$60,000 per mile
 - b. 135th Avenue is a prime candidate for seal coating
 - c. Suggested conferring with the Town of Trenton to determine if they are interested in seal coating their portion of 135th Avenue
 - d. 715th Street may benefit from seal coating after patching – the Highway Department will review and advise
- This yr-* 4. The Highway Department will confer with Jeff Holtz relative to sloping the northern bank of 170th Avenue west of County Road D (to minimize snow drifting)
5. Blade patching –
 - a. It was concurred that blade patching is an effective way of repairing aged asphalt roads
 - b. Preplanning is required because the asphalt plant devotes a single day to producing material for blade patching (higher oil content with smaller aggregate)
6. Road signs and the need for same were discussed. Department specialists will tour Isabelle roads and advise.

Mr. Johnson stated that the Highway Department had finished its major 2020 projects with minimal cleanup efforts remaining. That should allow more efforts to be devoted to Town of Isabelle projects during the rest of 2020.
