

RESOLUTION NO. 2021-41

RESOLUTION TO ADJUST THE WARD BOUNDARIES

IN THE TOWN OF TRENTON

WHEREAS, per WI Stats. 59.10(3)(b)(1) PIERCE COUNTY has submitted a tentative plan to the Town of Trenton for the creation of county supervisory districts that are substantially equal in population based on the 2020 census; and

WHEREAS, Wis. Stats 5.15(1) provides for the division of a municipality into wards; and

WHEREAS, Wis. Stats 5;15(2)(b) provides that population of a ward shall not contain more than 1,000 inhabitants; and

WHEREAS, Wis. Stats 5;15(4)(a) states the division resolution shall number all wards in the municipality beginning with number one, and shall describe the boundaries of each ward; and

WHEREAS, the polling place is to be located in Ward 1;

THEREFORE BE IT RESOLVED, that Ward 1 of the Town of Trenton be That part of the Town of Trenton lying northerly of the following described reference line: beginning at the intersection of County Rd C and 170th Avenue; thence westerly along 170th Avenue to intersection of State Road 35 and 170th Avenue; thence northwesterly to the intersection of US Highway 63 and State Road 35; thence northerly along US Highway 63 to 180th Avenue; thence westerly to 803rd Street; thence northly to 185th Avenue; thence westerly to County Rd VV; thence southerly along County Rd VV to State Road 35; thence westerly along State Road 35 to 830th Street; thence southerly to US Highway 63; thence southwesterly to the "Wisconsin Channel" of the Mississippi River; thence northwesterly and upstream along the Mississippi River to the west line of Section 33, T25N, R18W. Said area to be part of Supervisory District No.16, and the designated polling place shall be the Town Hall; and


BE IT FURTHER RESOLVED, that Ward 2 of the Town of Trenton be that part lying Southerly of the following described reference line: beginning at the

intersection of County Rd C and 170th Avenue; thence westerly along 170th Avenue to intersection of State Road 35 and 170th Avenue; thence northwesterly to the intersection of US Highway 63 and State Road 35; thence northerly along US Highway 63 to 180th Avenue; thence westerly to 803rd Street; thence northly to 185th Avenue; thence westerly to County Rd VV; thence southerly along County Rd VV to State Road 35; thence westerly along State Road 35 to 830th Street; thence southernly to US Highway 63; thence southwesterly to the "Wisconsin Channel" of the Mississippi River; thence northwesterly and upstream along the Mississippi River to the west line of Section 33, T25N, R18W. Said area to be part of Supervisory District No. 14, and the designated polling place shall be the Town Hall; and

BE IT FURTHER RESOLVED, that Wards 1 and 2 be combined for reporting election results, except for the election of County Board Supervisors; and


BE IT FURTHER RESOLVED that the designated polling place is the Town Hall located in Ward 1.
